

COLLECTED, AND SUCH TAX SHALL BEAR THE SAME INTEREST AND BE SUBJECT TO THE SAME PENALTIES IN THE EVENT OF NONPAYMENT, AS IN THE CASE OF OTHER COUNTY TAXES.

67-27. CONSOLIDATION OF BOND ISSUES; APPLICABILITY OF PROVISIONS.

WHENEVER THE COUNTY SHALL ISSUE BONDS UNDER THIS CHAPTER TOGETHER WITH ANY OTHER ISSUE OF BONDS FOR ANY PUBLIC PURPOSE, THE COUNTY MAY, IN ITS DISCRETION, CONSOLIDATE THE BONDS ISSUED HEREUNDER WITH THE ISSUE OR ISSUES OF BONDS FOR ANY OTHER PUBLIC PURPOSE. IF SUCH BOND ISSUES ARE CONSOLIDATED FOR SALE, THE COUNTY MAY REQUIRE THAT BIDS FOR SUCH CONSOLIDATED ISSUES OF BONDS BE SUBMITTED ON AN ALL OR NONE BASIS. THE PROVISIONS OF THIS SECTION SHALL APPLY TO ALL COUNTY LOANS NOW OR HEREAFTER AUTHORIZED NOTWITHSTANDING ANY PROVISIONS CONTAINED IN ANY ACT OR ACTS EXPRESSLY AUTHORIZING SUCH LOANS, AND ALL PROVISIONS OF SUCH ACT OR ACTS, TO THE EXTENT OF THEIR INCONSISTENCY WITH THE PROVISIONS OF THIS SECTION, ARE HEREBY REPEALED.

67-28. EFFECT OF PROVISIONS ON PRIOR DISTRICT OR COMMISSION; TRANSFER OF DUTIES, CONTRACT OR DEBTS.

A. IN THE EVENT THAT A SANITARY DISTRICT OR A SANITARY COMMISSION (A BODY POLITIC AND CORPORATE) HAS BEEN CREATED IN CECIL COUNTY PRIOR TO THE EFFECTIVE DATE OF THIS CHAPTER PURSUANT TO ANY PROVISION OF PUBLIC GENERAL OR PUBLIC LOCAL LAW APPLICABLE TO CECIL COUNTY, SUCH DISTRICT OR COMMISSION SHALL CEASE TO EXIST AS A BODY POLITIC AND CORPORATE ON THE EFFECTIVE DATE OF THIS CHAPTER AND IT SHALL NOT THEREAFTER BE NECESSARY FOR SUCH DISTRICT OR COMMISSION TO FILE ANY ORDINANCES, RESOLUTIONS, CERTIFICATES OR ARTICLES WITH ANY PERSON OR AGENCY EXCEPT AS MAY SPECIFICALLY BE PROVIDED IN THIS CHAPTER. NOTHING CONTAINED IN THIS CHAPTER SHALL BE CONSTRUED AS IMPAIRING OR AFFECTING IN ANY WAY THE VALIDITY OR ENFORCEABILITY OF ANY PROCEEDING OR ACTION TAKEN, OR ANY OBLIGATIONS OR INDEBTEDNESS INCURRED BY SUCH DISTRICT OR COMMISSION PRIOR TO THE EFFECTIVE DATE OF THIS CHAPTER. IN THE EVENT THAT A SANITARY DISTRICT SHALL HAVE BEEN CREATED IN CECIL COUNTY PRIOR TO THE EFFECTIVE DATE OF THIS CHAPTER, ANY SUCH SANITARY DISTRICT SHALL BE MERGED INTO, AND THEREBY BECOME A PART OF, THE AREA WITHIN WHICH THE COUNTY IS AUTHORIZED TO EXERCISE ITS POWER AND AUTHORITY BY THIS CHAPTER, SUBJECT TO THE PROVISIONS OF § 67-1 HEREOF; PROVIDED, HOWEVER, THAT SUCH MERGER SHALL IN NO WAY AFFECT THE SECURITY FOR ANY OUTSTANDING BONDS.

B. ALL DUTIES, CONTRACTS, DEBTS, ASSETS, REAL PROPERTY
