75-8. DISTRICT BOARD.

FOR THE PURPOSE OF ADMINISTERING THE DISTRICT, THE BOARD OF COUNTY COMMISSIONERS CONSTITUTES THE DISTRICT BOARD. THE DISTRICT BOARD IS A BODY CORPORATE BY THE NAME OF THE "OCTORARO LAKES SPECIAL TAXING DISTRICT," WITH THE RIGHT TO USE A COMMON SEAL, TO SUE AND BE SUED, AND TO DO ANY AND ALL OTHER CORPORATE ACTS FOR THE PURPOSE OF CARRYING OUT THE PROVISIONS OF THIS SUBTITLE.

75-9. ISSUANCE OF BONDS; BORROWING POWER.

FOR THE PURPOSE OF PROVIDING FUNDS FOR THE DESIGN, CONSTRUCTION, ESTABLISHMENT, AND IMPROVEMENT OF ROADS AND DRAINAGE IN THE DISTRICT:

A. THE BOARD OF COUNTY COMMISSIONERS MAY ISSUE BONDS UPON THE FULL FAITH AND CREDIT OF THE COUNTY; AND/OR

B. THE DISTRICT BOARD MAY BORROW FUNDS FROM ANY SOURCE.

75-10. TAX TO REPAY BONDS.

THE BOARD OF COUNTY COMMISSIONERS SHALL LEVY ANNUALLY UPON THE PROPERTY OWNERS IN THE DISTRICT A SUM SUFFICIENT TO REPAY WHATEVER BONDS ARE ISSUED BY THE BOARD, THE FUNDS FROM WHICH ARE USED FOR DISTRICT PURPOSES. THIS LEVY SHALL BE COLLECTED AS ALL OTHER TAXES IN THE COUNTY ARE COLLECTED AND SHALL BE PAID OVER TO THE COUNTY TREASURER FOR THE SOLE PURPOSE OF AMORTIZING THE BOND ISSUE OR ISSUES SPECIFIED IN § 75-9.

75-11. DEEDING OF ROADS TO COUNTY.

MONEY MAY NOT BE EXPENDED UNTIL THERE IS A BINDING AGREEMENT THAT ALL PRIVATELY OWNED ROADS COMMONLY USED BY THE PUBLIC AT LARGE ARE DEEDED TO THE COUNTY AFTER THEY HAVE BEEN BROUGHT UP TO APPROPRIATE STANDARDS.

CHAPTER 78
TREASURER

78-1. ELECTION; TERM OF OFFICE; DEPUTY; BONDS; EXPENSES; VACANCIES.

A. THE LEGAL AND QUALIFIED VOTERS OF CECIL COUNTY SHALL AT THE GENERAL STATE ELECTION, TO BE HELD IN THE YEAR 1954, AND EVERY FOUR (4) YEARS THEREAFTER, ELECT SOME PERSON, A
