

ARTICLE II  
MASTER ELECTRICIAN AND MASTER ELECTRICIAN LIMITED

99-13. DEFINITIONS.

THE TERM "MASTER ELECTRICIAN," AS USED IN THIS CHAPTER, INCLUDES ANY AND ALL PERSONS ENGAGED IN THE BUSINESS OF, OR HOLDING THEMSELVES OUT TO THE PUBLIC AS ENGAGED IN THE BUSINESS OF, INSTALLING, REPLACING, ERECTING, OR RELOCATING, OR CONTRACTING TO INSTALL, REPLACE OR ERECT, ELECTRIC WIRES OR CONDUCTORS, TO BE USED FOR THE TRANSMISSION OF ELECTRIC CURRENT FOR ELECTRIC LIGHT, HEAT, PROTECTIVE SIGNALING, OR POWER PURPOSES, OR MOULDINGS, DUCTS, RACEWAYS, OR CONDUITS FOR THE RECEPTION OR PROTECTION OF SUCH WIRES OR CONDUCTORS, OR TO ANY ELECTRICAL MACHINERY, APPARATUS, DEVICES OR FIXTURES TO BE USED FOR ELECTRIC LIGHT, HEAT, PROTECTIVE SIGNALING OR POWER PURPOSES. THE TERM "MASTER ELECTRICIAN LIMITED," AS USED IN THIS CHAPTER, INCLUDES ANY AND ALL PERSONS DETERMINED TO BE QUALIFIED BY THE BOARD TO ENGAGE IN OR HOLD THEMSELVES OUT TO THE PUBLIC TO ENGAGE IN ANY SPECIFIC PORTION OR PORTIONS OF THE BUSINESS IN WHICH A MASTER ELECTRICIAN MAY ENGAGE. A LICENSE OF "MASTER ELECTRICIAN" ISSUED AND IN ACCORDANCE WITH THE PROVISIONS OF THIS CHAPTER SHALL ENTITLE ANY SUCH PERSON SO LICENSED TO ENGAGE IN THE BUSINESS OF AND TO HOLD HIMSELF OUT TO THE PUBLIC AS ENGAGED IN THE BUSINESS OF INSTALLING, ERECTING, REPLACING AND RELOCATING, AND OF CONTRACTING TO INSTALL, ERECT, REPLACE AND RELOCATE, AS DEFINED UNDER MASTER ELECTRICIAN. A LICENSE OF "MASTER ELECTRICIAN LIMITED" ISSUED AND IN ACCORDANCE WITH THE PROVISIONS OF THIS CHAPTER SHALL ENTITLE ANY SUCH PERSON TO ENGAGE IN THAT PORTION OR PORTIONS OF THE BUSINESS AS DEFINED UNDER MASTER ELECTRICIAN SO SPECIFIED IN HIS LICENSE; PROVIDED, HOWEVER, THAT (A) NOTHING IN THIS CHAPTER SHALL APPLY TO ANY FIRM OR CORPORATION WHO HAS IN ITS EMPLOY A LICENSED MASTER ELECTRICIAN OR MASTER ELECTRICIAN LIMITED WHO WILL BE RESPONSIBLE FOR THE ELECTRICAL WORK FOR SAID FIRM OR CORPORATION, PROVIDED THAT SAID LICENSEE FILES AN APPLICATION FOR INSPECTION WITH THE RECOGNIZED ELECTRICAL INSPECTION AUTHORITY AT LEAST ONCE A YEAR FOR ALL ADDITIONS TO, OR REVISIONS OF, THE ELECTRICAL INSTALLATION; (B) NOTHING IN THIS CHAPTER SHALL FORBID INSERTION IN ELECTRICAL CIRCUITS BY UNLICENSED PERSON OF DEVICES OR APPLIANCES WHICH ARE PROPERLY DESIGNED FOR SUCH INSERTION AND FOR WHICH PROPER WIRING AND INSERTION DEVICES ARE INSTALLED; AND NOTHING IN THIS CHAPTER SHALL RESTRICT OR FORBID ANYONE FROM SERVICING EQUIPMENT IN THE FIELDS OF HEATING, AIR CONDITIONING, REFRIGERATION OR APPLIANCES.
