INTEREST UPON AT LEAST FIFTEEN (15) DAYS' NOTICE TO THE LICENSEE BY REGISTERED MAIL FOR ANY OF THE FOLLOWING CAUSES OR REASONS:

- A. PERMITTING ANY UNLICENSED PERSON, FIRM, OR CORPORATION TO APPLY FOR INSPECTION OF OR TO PERFORM ELECTRICAL WORK UNDER THE AUTHORITY OF A LICENSEE;
- B. PERFORMING OR PERMITTING THE PERFORMANCE OF GROSSLY DEFECTIVE OR DANGEROUS WORK;
- C. FAILING TO FILE AN APPLICATION WITH A RECOGNIZED INSPECTION AUTHORITY FOR INSPECTION OF WORK PERFORMED PRIOR TO COMMENCEMENT OF SUCH WORK, EXCEPT IN THE CASE OF AN EMERGENCY, IN WHICH CASE APPLICATION FOR INSPECTION MAY BE FILED AFTER THE FACT, OR EXCEPT WHEN THE VALUE OF THE WORK IS LESS THAN FIFTY DOLLARS (\$50.), IN WHICH CASE APPLICATION FOR INSPECTION WORK IS NOT NECESSARY;
- <u>D. FAILURE TO MAKE CORRECTION REQUIRED BY A NOTICE ISSUED</u>
 BY THE AUTHORIZED ELECTRICAL INSPECTOR WITHIN A REASONABLE
 TIME; OR
- E. VIOLATIONS OF ANY OF THE PROVISIONS OF THIS CHAPTER OR OF ANY REGULATIONS ADOPTED PURSUANT TO THIS CHAPTER.

99-22. ELECTRICAL STANDARDS.

ALL WORK PERFORMED AND INSTALLED BY A LICENSEE UNDER THIS CHAPTER SHALL BE IN ACCORDANCE WITH THE THEN CURRENT EDITION OF THE NATIONAL ELECTRICAL CODE, NFPA #70, OR APPROVED REVISIONS THEREOF, AS MAY BE AMENDED BY THE BOARD AND SHALL BE CERTIFIED BY THE RECOGNIZED ELECTRICAL INSPECTION AUTHORITY.

CHAPTER 104 FOXES

104-1. SHOOTING OR KILLING FOX PURSUED BY HOUNDS OR DOGS.

- A. ANY PERSON OR PERSONS WHO SHALL SHOOT, KILL OR WOUND ANY FOX OR FOXES WHILE BEING PURSUED BY HOUNDS OR HOUND WITHIN THE LIMITS OF CECIL COUNTY SHALL BE GUILTY OF A MISDEMEANOR AND, UPON CONVICTION THEREOF, SHALL PAY A FINE OF TEN DOLLARS (\$10.) FOR EVERY SUCH OFFENSE, TOGETHER WITH THE COSTS OF PROSECUTION, AND UPON FAILURE TO PAY THE SAME TO BE COMMITTED TO THE COUNTY JAIL UNTIL FINE AND COSTS ARE PAID.
- B. IT SHALL NOT BE LAWFUL TO SHOOT, SHOOT AT, TRAP, SET A TRAP FOR, INJURE OR KILL ANY FOX IN CECIL COUNTY WHILE SUCH FOX IS BEING PURSUED BY DOG OR DOGS.
