THE TAXICAB INDUSTRY FOR CECIL COUNTY SHALL BE IN ADDITION TO ANY REGULATION BY THE MOTOR VEHICLE ADMINISTRATION OR THE PUBLIC SERVICE COMMISSION OF MARYLAND.

B. ANY PERSON, FIRM, OR CORPORATION SUBJECT TO THIS CHAPTER WHO OR WHICH IS DISSATISFIED WITH ANY ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OR ITS AGENT, ENACTED PURSUANT TO THE AUTHORITY HEREIN CONFERRED, MAY COMMENCE AN ACTION IN THE CIRCUIT COURT OF CECIL COUNTY AGAINST THE BOARD OR ITS AGENT TO VACATE AND SET ASIDE THE ORDINANCE ON THE GROUND THAT THE REGULATION PRACTICE, ACT, OR SERVICE ESTABLISHED BY THE ORDINANCE IS UNREASONABLE OR UNLAWFUL. THE DECISION OF THE CIRCUIT COURT SHALL BE APPEALABLE TO THE COURT OF SPECIAL APPEALS OF MARYLAND BY EITHER PARTY, PROVIDED THE APPEAL IS ENTERED WITHIN TWENTY (20) DAYS AFTER THE JUDGMENT OF THE CIRCUIT COURT IS RENDERED.

147–3. VIOLATIONS AND PENALTIES.

ANY PERSON, FIRM OR CORPORATION VIOLATING ANY ORDINANCE PROMULGATED UNDER THE AUTHORITY OF § 147-2 IS GUILTY OF A MISDEMEANOR AND UPON CONVICTION THEREOF, SHALL BE PUNISHED BY A FINE OF NOT MORE THAN FIFTY DOLLARS (\$50.) FOR EACH OFFENSE. IN ADDITION, THE INCORPORATED TOWN OR THE COUNTY COMMISSIONERS OR THEIR AGENT, UPON PROOF OF ANY VIOLATION OF ANY ORDINANCE PROMULGATED UNDER § 147-2, MAY REVOKE OR SUSPEND ANY LICENSE ISSUED UNDER THE AUTHORITY OF § 147-2 AFTER AFFORDING REASONABLE OPPORTUNITY TO THE LICENSE TO BE HEARD IN HIS, HER, OR ITS DEFENSE.

<u>CHAPTER 151</u> TRAILERS AND TRAILER CAMPS

ARTICLE I VEHICULAR TRAILER CAMPS

151–1. LICENSES.

THE OPERATOR OF EVERY VEHICULAR TRAILER CAMP IN CECIL COUNTY SHALL OBTAIN A LICENSE IN ORDER TO OPERATE OR CONTINUE TO OPERATE SUCH TRAILER CAMP. THE LICENSE SHALL BE OBTAINED FROM THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY. FOR THE PURPOSE OF THIS ARTICLE, A VEHICULAR TRAILER CAMP IS DEFINED AS AN ESTABLISHMENT IN CECIL COUNTY WHICH LEASES TWO (2) OR MORE TRAILER COACH SPACES AND SUPPLIES UTILITY SERVICES TO SUCH TRAILERS. A LICENSE ISSUED TO THE OPERATOR OF ANY VEHICULAR TRAILER CAMP SHALL BE TRANSFERABLE TO A SUCCESSOR OPERATOR OF THE SAME TRAILER CAMP.
