~~(2) SEASONAL LICENSING REQUIREMENTS. APPLICANTS WHO OWN OR OPERATE HOTELS, SUMMER RESORTS OR ANY TYPE OF SEASONAL BUSINESS AND WHO ARE NOT OPEN FOR BUSINESS THE ENTIRE YEAR MAY OBTAIN A SEASONAL LICENSE BY THE PAYMENT OF A FEE OF ONE HUNDRED FIFTY DOLLARS (\$150.) FOR EACH MACHINE WITH A SINGLE SLOT OR RECEPTACLE SOUGHT TO BE LICENSED UP TO AND INCLUDING THIRTY FIVE (35) MACHINES. FOR MULTIPLE SLOT OR CONSOLE MACHINES, THE ADDITIONAL FEE OF TWENTY FIVE DOLLARS (\$25.) PER SLOT SHALL BE PAID AS PRESCRIBED BY THIS SUBSECTION. THE PAYMENT OF SAID FEES SHALL AUTHORIZE THE OWNER OR OPERATOR TO MAINTAIN ON SUCH PREMISES THE LICENSED MACHINES FROM MAY 1 TO OCTOBER 1 IN ANY YEAR.~~

~~B. NUMBER OF MACHINES RESTRICTED. IN NO EVENT SHALL MORE THAN THIRTY FIVE (35) MACHINES BE OPERATED IN ANY ONE (1) BUILDING OR PREMISES, NOR SHALL ANY SUCH LICENSEE HAVE ANY INTEREST, DIRECT OR INDIRECT, IN THE OPERATION OF MORE THAN THIRTY FIVE (35) MACHINES, IT BEING THE INTENTION OF THIS SUBSECTION TO PROHIBIT THE OPERATION OF MORE THAN THIRTY FIVE (35) MACHINES IN ANY ONE (1) BUILDING OR PREMISES, REGARDLESS OF WHETHER SUCH LICENSEES ARE DIRECTLY OR INDIRECTLY INTEREST IN THE OPERATION OF SUCH MACHINES, AND TO FURTHER PROHIBIT ANY SUCH PERSON, FIRM OR CORPORATION FROM HAVING ANY INTEREST, DIRECT OR INDIRECT, IN THE OPERATION OF MORE THAN THIRTY FIVE (35) MACHINES IN CHARLES COUNTY, REGARDLESS OF WHERE SUCH MACHINES MAY BE LOCATED; PROVIDED, HOWEVER, THAT ANY OPERATOR LICENSED UNDER THIS SUBSECTION WHO DESIRES TO DISCONTINUE THE OPERATION OF THE MACHINES WHICH HE MAY OWN MAY, UPON APPLICATION TO THE BOARD OF COUNTY COMMISSIONERS AND WITH THE APPROVAL THEREOF, OFFER SUCH MACHINES FOR SALE.~~

~~C. LICENSE TO SELL OR LEASE. ANY PERSON, FIRM OR CORPORATION WHO DOES NOT DESIRE TO MAINTAIN AND OPERATE ANY SUCH AMUSEMENT DEVICES BUT MERELY TO SELL OR LEASE THE SAME MAY OBTAIN A LICENSE THEREFOR, PROVIDED THAT SUCH PERSON, FIRM OR CORPORATION HAS THE QUALIFICATIONS REQUIRED OF A LICENSEE UNDER § 4 1B OF THIS ARTICLE, UPON APPLICATION TO SAID LICENSE CLERK AND UPON THE PAYMENT OF AN ANNUAL LICENSE FEE OF FIVE THOUSAND DOLLARS (\$5,000.), WHICH LICENSE SHALL ONLY AUTHORIZE SUCH LICENSEES FOR THE MAINTENANCE AND OPERATION OF SUCH AMUSEMENT MACHINES UNDER A LICENSE AUTHORIZED BY THIS ARTICLE, EXCEPT AS AUTHORIZED IN SUBSECTION A OF THIS SECTION.~~
