

~~PROPER LICENSE FEE AND UPON APPROVAL OF THE BOARD OF COUNTY COMMISSIONERS, THE CLERK SHALL ISSUE AN APPROPRIATE CERTIFICATE EVIDENCING THAT SUCH LICENSE IS THEREBY ISSUED AND THE REQUIRED LICENSE FEES ARE THEREBY PAID, AND SAID CERTIFICATE SHALL ENUMERATE AND LIST A NUMBER FOR EACH OF THE DEVICES THEREBY LICENSED FOR SAID PREMISES. AT THE TIME OF ISSUING SAID CERTIFICATE, THE CLERK SHALL ALSO ISSUE A METAL PLATE WHICH SHALL HAVE STAMPED THEREON A NUMBER CORRESPONDING TO THE NUMBER ASSIGNED TO THE DEVICE ON THE CERTIFICATE, WHICH METAL PLATE THEREAFTER SHALL BE SECURELY FASTENED TO THE AMUSEMENT DEVICE IN SUCH A MANNER AS WILL BE VISIBLE. ALL MACHINES OR DEVICES LICENSED HEREUNDER SHALL BE MAINTAINED AND OPERATED ON THE INSIDE OF THE LICENSED PREMISES ONLY.~~

~~H. DISTRIBUTOR'S REPORTS. EACH DISTRIBUTOR SECURING A LICENSE HEREUNDER SHALL, ON OR BEFORE THE 10TH DAY OF EACH MONTH, REPORT THE NAME AND ADDRESS OF EVERY PERSON, FIRM OR CORPORATION RESIDING OR HAVING A PLACE OF BUSINESS IN CHARLES COUNTY TO WHOM ANY SUCH AMUSEMENT MACHINE OR DEVICE HAS BEEN SOLD OR LEASED BY HIM DURING THE PRECEDING MONTH.~~

~~I. EXPIRATION OF LICENSE. ALL LICENSES ISSUED UNDER THIS SECTION SHALL EXPIRE ON APRIL 30 OF EACH YEAR. EACH LICENSE FEE SHALL BE PRORATED TO THE MONTH OF ISSUE, BUT NO REFUND SHALL BE ALLOWED FOR CEASING TO EXERCISE THE PRIVILEGE OF THE LICENSE BEFORE EXPIRATION.~~

~~J. APPROVAL BY COUNTY. NO LICENSE SHALL BE ISSUED UNDER THIS ARTICLE UNLESS APPROVED BY THE COUNTY COMMISSIONERS OF CHARLES COUNTY. SAID COUNTY COMMISSIONERS SHALL HAVE THE RIGHT TO REJECT AN APPLICATION FOR LICENSE FOR SUFFICIENT CAUSE, AND IN THE EVENT THAT AN APPLICATION IS REJECTED, A WRITTEN STATEMENT SHALL BE DELIVERED TO THE APPLICANT, TOGETHER WITH THE NOTICE OF REJECTION, SETTING FORTH THE REASONS FOR REJECTION. SUCH DECISION SHALL BE SUBJECT TO REVIEW BY THE CIRCUIT COURT FOR CHARLES COUNTY.~~

~~A. APPOINTMENT; BOND. THE COUNTY COMMISSIONERS SHALL APPOINT A LICENSE CLERK AND A LICENSE INSPECTOR WHO, PRIOR TO ASSUMING OFFICES, SHALL EXECUTE A GOOD BOND, IN THE PENALTY OF ANY AMOUNT WHICH SHALL BE FIXED BY THE COUNTY COMMISSIONERS, FOR THE FAITHFUL PERFORMANCE OF THEIR DUTIES AS LICENSE CLERK AND LICENSE INSPECTOR AND FURTHER CONDITIONED THAT THEY SHALL WELL AND TRULY ACCOUNT FOR AND PAY OVER TO THE PERSON OR PERSONS OR BODY CORPORATE ENTITLED THERETO ANY AND ALL MONEY AND PROPERTY COMING~~
