

~~INTO THEIR POSSESSION AS LICENSE CLERK AND LICENSE INSPECTOR, WHICH BONDS SHALL BE APPROVED BY THE COUNTY COMMISSIONERS OR A MAJORITY OF THEM. THE COUNTY COMMISSIONERS MAY REQUIRE THE LICENSE CLERK AND LICENSE INSPECTOR TO GIVE AS SURETY IN THE BONDS REQUIRED OF THEM BY THIS SECTION ONE (1) OF THE CORPORATIONS AUTHORIZED BY THE LAWS OF THIS STATE TO BECOME SURETY ON OFFICIAL BONDS, PROVIDED THAT IN SUCH CASE SAID COUNTY COMMISSIONERS SHALL PAY THE PREMIUMS OR CHARGES FOR SUCH SURETYSHIPS. SAID LICENSE CLERK SHALL SERVE AT THE PLEASURE OF SAID COUNTY COMMISSIONERS AT SUCH HOURS AS THEY SHALL REASONABLY DESIGNATE AND SHALL ISSUE ALL LICENSES PROVIDED FOR HEREIN AND COLLECT ALL SUMS REQUIRED TO BE PAID THEREFOR. SUMS COLLECTED SHALL BE DEPOSITED IN SUCH BANKS AS SAID COMMISSIONERS SHALL DESIGNATE TO THE CREDIT OF THE COUNTY COMMISSIONERS AS COUNTY FUNDS.~~

~~B. LICENSE CLERK. THE LICENSE CLERK SHALL PERFORM SUCH OTHER DUTIES AS MAY BE DESIGNATED BY THE COUNTY COMMISSIONERS AND SHALL HAVE SUCH ANNUAL COMPENSATION AS THE COUNTY COMMISSIONERS MAY FIX.~~

~~C. LICENSE INSPECTOR.~~

~~(1) POWERS AND DUTIES. THE COUNTY COMMISSIONERS SHALL APPOINT THE AFOREMENTIONED LICENSE INSPECTOR, WHO SHALL SERVE AT THE PLEASURE OF SAID COUNTY COMMISSIONERS AND SHALL PERFORM SUCH DUTIES AS THE COUNTY COMMISSIONERS REQUIRE IN CONNECTION WITH THE ENFORCEMENT AND ADMINISTRATION OF THE PROVISIONS OF THIS ARTICLE. IT SHALL BE THE DUTY OF THE INSPECTOR TO MAKE SUCH INVESTIGATIONS AND CONDUCT SUCH EXAMINATIONS OF THE RECORDS OF LICENSEES AS WILL SATISFY HIM THAT THE PROVISIONS OF THIS ARTICLE ARE BEING FULLY COMPLIED WITH BY SAID LICENSEES. SAID INSPECTOR SHALL HAVE THE RIGHT AT ANY TIME TO INSPECT ANY MACHINE INTERNALLY OR EXTERNALLY LICENSED UNDER THIS ARTICLE OR THE PREMISES WHERE SUCH MACHINES ARE OPERATED OR STORED. HE SHALL HAVE THE RIGHT TO SEIZE ANY MACHINE OR OTHER EVIDENCE OF VIOLATION OF ANY PROVISION OF THIS ARTICLE AND TO HOLD THE SAME AS EVIDENCE PENDING TRIAL OF THE LICENSEE.~~

~~(2) COMPENSATION. FOUR THOUSAND DOLLARS (\$4,000.) SHALL BE PAID TO THE LICENSE INSPECTOR AS HEREIN PROVIDED AS ANNUAL COMPENSATION FOR HIS SERVICES, AND AN ADDITIONAL SUM OF NINE HUNDRED DOLLARS (\$900.) PER YEAR SHALL BE PAID TO SAID LICENSE INSPECTOR FOR HIS EXPENSES. PROPORTIONATE PARTS OF THE PAYMENTS PROVIDED FOR IN THIS SUBSECTION SHALL BE MADE BIMONTHLY.~~
