

~~4.4. PENALTY PROVISIONS CONCERNING OPERATION OF UNLICENSED DEVICES AND OPERATION BY MINORS.~~

~~IT SHALL BE UNLAWFUL FOR ANY PERSON, FIRM OR CORPORATION KNOWINGLY TO OPERATE OR PERMIT THE OPERATION OF ANY AMUSEMENT MACHINE OR DEVICE AUTHORIZED TO BE LICENSED UNDER THIS ARTICLE OR PERMIT ANY SUCH MACHINE OR DEVICE TO BE OPERATED OR PLAYED BY ANY PERSON UNDER SIXTEEN (16) YEARS OF AGE OR FOR SUCH MINOR TO OPERATE SUCH MACHINE OR DEVICE. ANY PERSON, FIRM OR CORPORATION VIOLATING THE PROVISIONS OF THIS SECTION SHALL BE GUILTY OF A MISDEMEANOR AND, UPON CONVICTION THEREOF, SHALL BE PUNISHED BY A FINE OF FIFTY DOLLARS (\$50.) FOR THE FIRST OFFENSE AND ONE HUNDRED DOLLARS (\$100.) FOR THE SECOND OFFENSE AND SHALL ALSO HAVE HIS LICENSE REVOKED FOR SUCH SECOND OFFENSE, AND HE SHALL NOT BE ELIGIBLE TO OBTAIN, EITHER DIRECTLY OR INDIRECTLY, ANOTHER LICENSE FOR A TWO YEAR (2 YEAR) PERIOD FOLLOWING SUCH REVOCATION.~~

~~4.5. VIOLATIONS AND PENALTIES GENERALLY.~~

~~A. UNLAWFUL ACTS.~~

~~(1) TAMPERING. NO MACHINE LICENSED UNDER THE PROVISIONS OF THIS ARTICLE SHALL BE TAMPERED WITH IN ANY MANNER WHICH WILL AFFECT THE NORMAL PAYOFF OPERATION OF THE MACHINE. THE USE OF WEIGHTS, BALANCES OR ANY OTHER DEVICES MECHANICAL OR ELECTRICAL, DESIGNED TO AFFECT THE ODDS OF THE PLAY SHALL BE CONSIDERED AS TAMPERING UNDER THIS ARTICLE.~~

~~(2) INDUCEMENTS. NO LICENSEE SHALL OFFER REWARDS OF ANY KIND, CASH OR MERCHANDISE, AS INDUCEMENT TO PLAY THE MACHINE, IN ADDITION TO THE NORMAL CASH PAYOFF AND GUARANTEED PAYOFF DESIGNATED ON THE MACHINE.~~

~~(3) ADVERTISING. NO LICENSEE, HIS AGENT OR EMPLOYEE SHALL ADVERTISE, DIRECTLY OR INDIRECTLY, THE OPERATION OF MACHINES UNDER THE PROVISIONS OF THIS ARTICLE.~~

~~(4) ALTERATIONS. IT SHALL BE UNLAWFUL FOR ANYONE TO OBLITERATE, REMOVE, CHANGE OR ALTER THE MANUFACTURER'S IDENTIFICATION MARK OR NUMBER OF ANY MACHINE. WHENEVER, ON TRIAL FOR A VIOLATION OF THIS SECTION, THE DEFENDANT IS SHOWN TO HAVE OR HAVE HAD POSSESSION OF ANY SUCH MACHINE, SUCH FACT SHALL BE PRESUMPTIVE EVIDENCE THAT THE DEFENDANT OBLITERATED, REMOVED, CHANGED OR ALTERED THE MANUFACTURER'S IDENTIFICATION MARK OR NUMBER.~~
