- (B) THE CANCELLATION OF SCHEDULED MEETINGS.
- B. THE SALARY OF THE PRESIDENT OF THE COUNTY COMMISSIONERS IS:
- (1) THIRTY-TWO THOUSAND AND FIVE HUNDRED DOLLARS (\$32,500.) FOR THE CALENDAR YEAR 1991;
- (2) THIRTY-FOUR THOUSAND DOLLARS (\$34,000.) FOR THE CALENDAR YEAR 1992;
- (3) THIRTY-FIVE THOUSAND AND FIVE HUNDRED DOLLARS (\$35,500.) FOR THE CALENDAR YEAR 1993; AND
- (4) THIRTY-SEVEN THOUSAND DOLLARS (\$37,000.) FOR THE CALENDAR YEAR 1994.
  - C. THE SALARY FOR THE CHARLES COUNTY COMMISSIONERS IS:
- (1) TWENTY-THREE THOUSAND AND FIVE HUNDRED DOLLARS (\$23,500.) FOR THE CALENDAR YEAR 1991;
- (2) TWENTY-FIVE THOUSAND DOLLARS (\$25,000.) FOR THE CALENDAR YEAR 1992;
- (3) TWENTY-SIX THOUSAND AND FIVE HUNDRED DOLLARS (\$26,500.) FOR THE CALENDAR YEAR 1993; AND
- (4) TWENTY-EIGHT THOUSAND DOLLARS (\$28,000.) FOR THE CALENDAR YEAR 1994.
- D. THE COUNTY COMMISSIONERS MAY NOT RECEIVE MILEAGE FOR ATTENDING REGULAR MEETINGS, BUT SHALL BE REIMBURSED FOR MILEAGE, TOOLS AND PARKING EXPENSES INCURRED IN TRAVEL TO OTHER MEETINGS IN CONNECTION WITH THEIR DUTIES AS COUNTY COMMISSIONERS. REIMBURSEMENT SHALL BE MADE UPON THE SUBMISSION OF VOUCHERS FOR THE EXPENSES MONTHLY AND AFTER THE APPROVAL OF THE VOUCHERS BY A MAJORITY OF THE COUNTY COMMISSIONERS.
- 27-3. PUBLICATION OF COUNTY MATTERS; NEWSPAPER CONTRACTS.

THE COUNTY COMMISSIONERS OF CHARLES COUNTY SHALL, IN EACH AND EVERY YEAR, AS SOON AS PRACTICABLE AFTER THE ANNUAL LEVY, CONTRACT FOR PUBLISHING, FOR THE PERIOD OF ONE (1) YEAR FROM THE FIRST DAY OF JULY IN THE YEAR IN WHICH SAID CONTRACT SHALL BE MADE, ALL MATTERS REQUIRED BY LAW TO BE PUBLISHED BY SAID COUNTY COMMISSIONERS, EXCEPT SUCH MATTERS RELATING TO THE REGISTERING OF VOTERS AND TO ELECTIONS AS MAY BE REQUIRED BY LAW TO BE PUBLISHED BY THE SUPERVISORS OF ELECTIONS OF SAID COUNTY OR SUCH OTHER REGISTRATION AND ELECTION OFFICIALS AS MAY BE CHARGED WITH THE DUTY OF
