INSTANCE THE EXECUTION WAS ISSUED OR HIS ATTORNEY OR, IN THE ABSENCE OF SUCH DIRECTION, BY THE SHERIFF.

27-5. APPROPRIATIONS FOR LIBRARY FACILITIES.

THE COUNTY COMMISSIONERS OF CHARLES COUNTY ARE HEREBY AUTHORIZED AND DIRECTED TO APPROPRIATE A SUM OF TWENTY THOUSAND DOLLARS (\$20,000.) FROM GENERAL FUNDS OF THE COUNTY IN THE YEAR 1957 FOR LIBRARY FACILITIES, THE SAME TO BE LOCATED BETWEEN INDIAN HEAD AND BRYANS ROAD NEAR STATE ROUTE 210, AND TO APPROPRIATE SUCH SUMS OF MONEY ANNUALLY THEREAFTER AS MAY BE NECESSARY TO MAINTAIN SUCH FACILITIES.

27-6. CLERK TO THE COUNTY COMMISSIONERS.

A. APPOINTMENT; BOND. THE COUNTY COMMISSIONERS SHALL ANNUALLY APPOINT A CLERK, WHO SHALL BE LIABLE TO REMOVAL BY SAID COMMISSIONERS, WHO SHALL FILL ANY VACANCY IN SAID OFFICE AT THE NEXT MEETING THEREAFTER OR AS SOON AS PRACTICABLE. SAID CLERK SHALL GIVE BOND TO THE STATE OF MARYLAND, TO BE APPROVED BY SAID COUNTY COMMISSIONERS, IN THE PENALTY OF FIVE THOUSAND DOLLARS (\$5,000.), CONDITIONED FOR THE FAITHFUL PERFORMANCE OF THE DUTIES IMPOSED UPON HIM AS SUCH CLERK, WHICH BOND SHALL BE RECORDED IN THE OFFICE OF THE CLERK OF THE CIRCUIT COURT OF SAID COUNTY.

B. POWERS AND DUTIES.

- (1) COPIES OF COUNTY DOCUMENTS; FEES. HE SHALL, UPON APPLICATION, EXHIBIT THE BOOKS, PAPERS AND LEVIES IN HIS OFFICE AND MAKE CERTIFIED COPIES OR EXTRACTS THEREOF FOR ANY PERSON DEMANDING THE SAME AND CHARGE FOR THE SAME, FOR THE USE OF THE COUNTY, SUCH FEES AS ARE CHARGEABLE BY THE CLERK OF THE CIRCUIT COURT FOR SIMILAR WORK, AND SUCH COPIES, UNDER THE SEAL OF THE COUNTY COMMISSIONERS, SHALL BE EVIDENCE TO THE SAME EXTENT AS THE ORIGINALS WOULD BE IF PRODUCED IN PROCEEDINGS IN COURT OR OTHERWISE. ALL FEES RECEIVED FROM THIS SOURCE, HOWEVER, SHALL BE ACCOUNTED FOR TO THE COUNTY COMMISSIONERS BY SAID CLERK AND TREASURER.
- (2) TRANSFER CLERK. THE CLERK TO THE COUNTY ASSESSOR SHALL ACT AS TRANSFER CLERK AND SHALL ENTER ON THE ASSESSMENT BOOKS ALL TRANSFERS OF PROPERTY IN CHARLES COUNTY AND SHALL KEEP SUCH HOURS AS SHALL BE SET BY THE COUNTY COMMISSIONERS.
- C. COMPENSATION. HE SHALL RECEIVE A SALARY AS DETERMINED BY THE COUNTY COMMISSIONERS AND SHALL RECEIVE NO EXTRA OR OTHER COMPENSATION OR FEES OF ANY KIND FOR THE
