- (A) CALVERT COUNTY: TWO THOUSAND DOLLARS (\$2,000.).
- (B) CHARLES COUNTY: FOUR THOUSAND DOLLARS (\$4,000.).
- (C) ST. MARY'S COUNTY: FOUR THOUSAND DOLLARS (\$4,000.).
- (3) THE SUMS SO APPROPRIATED SHALL BE USED, TOGETHER WITH FUNDS PRESENTLY AVAILABLE TO THE COMMITTEE, FOR THE PURPOSE OF SECURING THE SERVICES OF A PLANNER, TO BE KNOWN AS THE "TRI-COUNTY PLANNER."
- E. PORT TOBACCO COURTHOUSE. THE COUNTY COMMISSIONERS OF CHARLES COUNTY ARE AUTHORIZED TO APPROPRIATE A SUM OF MONEY, IN THEIR DISCRETION, TO ASSIST IN THE RESTORATION OF THE COURTHOUSE AT PORT TOBACCO AND TO PROVIDE, IN ADDITION, SUCH SUMS AS THEY MAY DETERMINE TO BE NECESSARY ANNUALLY THEREAFTER FOR THE MAINTENANCE OF THE RESTORED BUILDING.

## F. RETIREMENT SALARIES.

- (1) THE COUNTY COMMISSIONERS OF CHARLES COUNTY SHALL APPROPRIATE ANNUALLY A SUM OF MONEY SUFFICIENT TO FINANCE A RETIREMENT SALARY AS PROVIDED IN SUBSECTION F(2) OF THIS SECTION TO PERSONS SIXTY-FIVE (65) YEARS OF AGE AND OVER WHO NO LONGER HOLD ELECTIVE PUBLIC OFFICE BUT WHO HAVE HELD ONE (1) OF THE FOLLOWING ELECTED PUBLIC OFFICES OF CHARLES COUNTY FOR THE NUMBER OF TERMS SPECIFIED IN SUBSECTION F(2) OF THIS SECTION:
  - (A) COUNTY COMMISSIONER.
  - (B) COUNTY TREASURER.
  - (C) STATE'S ATTORNEY.
  - (D) JUDGE OF THE ORPHANS' COURT.
- (2) SUCH PERSONS WHO HAVE HELD ONE (1) OR MORE OF THE ELECTED PUBLIC OFFICES OF CHARLES COUNTY ENUMERATED IN SUBSECTION F(1) OF THIS SECTION FOR A COMBINED TOTAL OF FOUR (4) FULL TERMS SHALL BE ENTITLED TO AN ANNUAL RETIREMENT SALARY IN AN AMOUNT EQUAL TO THE TOTAL OF FIVE PERCENT (5%) OF EACH OF THE HIGHEST ANNUAL SALARIES RECEIVED BY THE PERSON FOR EACH YEAR HE HELD OFFICE; PROVIDED, HOWEVER, THAT THE MAXIMUM ANNUAL RETIREMENT SALARY SHALL NOT EXCEED EIGHTY PERCENT (80%) OF THE HIGHEST ANNUAL SALARY THE PERSON RECEIVED WHILE HOLDING ONE (1) OF THOSE OFFICES, AND PROVIDED, FURTHER, THAT THE AMOUNT OF ANY PENSION BEING PAID TO A
