

CHAPTER 114  
SCHOLARSHIPS

114-1. SCHOLARSHIP PROGRAM.

A. SCHOLARSHIPS ESTABLISHED. A PROGRAM OF SCHOLARSHIPS IS HEREBY ESTABLISHED FOR COURSES OF STUDY LEADING TO THE CERTIFICATE, DIPLOMA OR OTHER EVIDENCE OF QUALIFICATION TO PRACTICE ON COMPLETION OF SPECIALIZED TRAINING IN CATEGORIES AS SPECIFIED BY THE COUNTY COMMISSIONERS.

B. SCHOLARSHIPS AWARDED PURSUANT TO ESTABLISHED CRITERIA. SCHOLARSHIPS UNDER THIS CHAPTER SHALL BE AWARDED TO RECIPIENTS IN AN AMOUNT AND NUMBER THAT IS IN ACCORDANCE WITH CRITERIA SPECIFIED BY THE COUNTY COMMISSIONERS.

C. APPROPRIATION OF FUNDS; AUTHORITY TO EXCUSE RECIPIENT FROM SUBSEQUENT COUNTY PRACTICE. THE COUNTY COMMISSIONERS ARE AUTHORIZED AND EMPOWERED TO APPROPRIATE FUNDS FOR SCHOLARSHIPS HEREUNDER FROM THE GENERAL FUNDS OF CHARLES COUNTY AND TO EXCUSE A SCHOLARSHIP RECIPIENT, AT THE DISCRETION OF THE COUNTY COMMISSIONERS, FROM FULFILLING A REQUIREMENT THAT THE SCHOLARSHIP RECIPIENT PRACTICE IN THE RECIPIENT'S FIELD IN CHARLES COUNTY AFTER COMPLETING THE SPECIALIZED TRAINING OR COURSE OF INSTRUCTION FOR WHICH THE SCHOLARSHIP WAS AWARDED.

CHAPTER 116  
SCHOOLS

116-1. PUBLICATION REQUIREMENTS FOR SCHOOL STATEMENTS.

THE BOARD OF COUNTY SCHOOL COMMISSIONERS OF CHARLES COUNTY SHALL PUBLISH IN THREE (3) NEWSPAPERS HAVING A GENERAL CIRCULATION IN THE COUNTY A STATEMENT OF ALL RECEIPTS AND DISBURSEMENTS, INCLUDING ALL MONEY RECEIVED AND EXPENDED ON ACCOUNT OF TEXTBOOKS, AND A STATEMENT OF THE INDEBTEDNESS OF THE BOARD AT THE CLOSE OF THE FISCAL YEAR AND THE ITEMS OF EXPENSE OF THE SEVERAL PUBLIC SCHOOLS IN CHARLES COUNTY, AS NOW REQUIRED TO BE PUBLISHED BY SAID BOARD UNDER THE PROVISIONS OF SECTION 27 OF ARTICLE 77 OF THE CODE OF PUBLIC GENERAL LAWS OF MARYLAND, TITLE "PUBLIC EDUCATION," SUBTITLE "COUNTY SCHOOL COMMISSIONERS," AND INCLUDING ALSO ALL OTHER MATTERS OF WHICH THE PUBLIC SHOULD BE INFORMED, IN THE DISCRETION OF SAID BOARD; PROVIDED, HOWEVER, THAT SAID BOARD OF COUNTY SCHOOL COMMISSIONERS SHALL NOT ALLOW, AS COMPENSATION OR CONSIDERATION FOR THE PUBLICATIONS HEREINBEFORE MENTIONED, MORE THAN THE CURRENT RATES CHARGED BY SAID NEWSPAPERS FOR SUCH LIKE ADVERTISING, AND PROVIDED, FURTHER, THAT IN THE EVENT THAT THE PUBLISHERS OR
