

THE RESIDENTS AND TAXPAYERS WITHIN THE PROPOSED DRAINAGE FACILITIES DISTRICT SHALL BE GIVEN AN OPPORTUNITY TO BE HEARD.

D. NOTICE OF THE HEARING SHALL BE PUBLISHED AT LEAST ONCE IN A NEWSPAPER OF GENERAL CIRCULATION IN THE AREA WHERE THE PROPOSED DRAINAGE FACILITIES DISTRICT IS TO BE LOCATED.

E. FOLLOWING THE HEARING THE COUNTY COMMISSIONERS MAY ESTABLISH THE DRAINAGE FACILITIES DISTRICT AND LEVY ON ALL PROPERTY THAT IS SUBJECT TO ORDINARY COUNTY TAXES AND LOCATED WITHIN THE DISTRICT A SPECIAL ASSESSMENT OVER A FIFTEEN-YEAR (15-YEAR) PERIOD TO RECOVER THE COSTS OF THE CONSTRUCTION AND MAINTENANCE OF THE DRAINAGE FACILITIES.

F. ALL SUCH SPECIAL ASSESSMENTS SHALL BE LEVIED IN THE SAME MANNER, UPON THE SAME ASSESSMENTS, FOR THE SAME PERIOD OR PERIODS, AND AS OF THE SAME DATE OR DATES OF FINALITY AS ARE PRESCRIBED BY LAW.

CHAPTER 125 SHERIFF

125-1. CARE OF STATE PRISONERS.

THE SHERIFF OF CHARLES COUNTY SHALL FURNISH ALL STATE PRISONERS CONFINED IN JAIL SUITABLE BED AND BEDDING, SHALL HAVE THEIR CLOTHES REGULARLY WASHED AND SHALL FURNISH FIRE WHEN NECESSARY TO KEEP THEM COMFORTABLE.

125-2. PER DIEM ALLOWANCE.

SAID SHERIFF OF CHARLES COUNTY SHALL RECEIVE FOR THE MAINTENANCE OF PRISONERS COMMITTED TO HIS CUSTODY IN THE COUNTY JAIL A SUM NOT TO EXCEED ONE DOLLAR (\$1.) PER HEAD PER DAY, AND THE COUNTY COMMISSIONERS SHALL IN NO CASE ALLOW A GREATER COMPENSATION.

125-3. SURETY BOND REQUIRED; CONDITIONS.

THE SHERIFF OF CHARLES COUNTY, BEFORE HE ACTS AS SUCH, SHALL GIVE BOND TO THE STATE OF MARYLAND IN THE PENALTY OF TEN THOUSAND DOLLARS (\$10,000.) AND NOT MORE THAN TEN THOUSAND DOLLARS (\$10,000.), WITH SECURITY TO BE APPROVED BY TWO (2) JUDGES OF THE ORPHANS' COURT OR ONE (1) OF THE JUDGES OF THE CIRCUIT COURT FOR SAID COUNTY, TO BE CONDITIONED AS NOW PROVIDED BY ARTICLE 87, § 2, OF THE CODE OF PUBLIC GENERAL LAWS OF THIS STATE AND TO BE SUBJECT TO THE SAME PROVISIONS AS NOW PROVIDED IN SAID ARTICLE FOR FAILURE TO GIVE AND OFFER FOR RECORD SUCH BOND PRIOR TO THE FIRST DAY OF JANUARY.
