

NAME OF THE NEW OWNER. THE COUNTY COMMISSIONERS ARE HEREBY AUTHORIZED TO PROVIDE SUCH ADDITIONAL CLERICAL HELP AS MAY BE NECESSARY TO CARRY OUT THE TERMS OF THIS SECTION.

B. TIME LIMIT FOR FURNISHING COPY OF TRANSFER. THE ASSESSOR'S OFFICE SHALL FURNISH THE TREASURER'S OFFICE A COPY OF THE TRANSFER OF REAL PROPERTY WITHIN SEVEN (7) WORKING DAYS AFTER RECEIPT OF THE RECORD OF TRANSFER.

136-4. GENERAL REQUIREMENTS; COLLECTION AND ACCOUNTING UPON EXPIRATION OF TERM.

A. OATH OF OFFICE. THE PERSON SO ELECTED AS AFORESAID SHALL, BEFORE HE ENTERS UPON THE DUTIES OF HIS SAID OFFICE, TAKE AN OATH BEFORE THE CLERK OF THE CIRCUIT COURT FOR CHARLES COUNTY IN FORM SIMILAR TO THAT NOW TAKEN BY COLLECTORS OF TAXES, EXCEPT AS TO THE TITLE OF THE OFFICE, AND BE SIMILARLY CERTIFIED.

B. BOND REQUIREMENTS. HE SHALL EXECUTE TO THE STATE OF MARYLAND A SEPARATE BOND IN THE SUM OF FIFTEEN THOUSAND DOLLARS (\$15,000.) AS THE COLLECTOR OF STATE TAXES, WHICH BOND SHALL BE APPROVED IN LIKE MANNER AS THE BONDS OF COLLECTORS OF STATE TAXES UNDER EXISTING LAW, AND HE SHALL EXECUTE TO THE STATE OF MARYLAND A SEPARATE BOND IN THE PENAL SUM OF TWENTY-FIVE THOUSAND DOLLARS (\$25,000.) TO BE APPROVED BY THE COUNTY COMMISSIONERS OF CHARLES COUNTY AS THE BONDS OF COLLECTORS OF COUNTY TAXES ARE NOW APPROVED, BOTH OF WHICH SAID BONDS SHALL BE IN THE SAME FORM, AS FAR AS THE SAME CAN BE APPLICABLE TO THE OFFICE OF TREASURER, AS THE BONDS OF COLLECTORS FOR STATE AND COUNTY TAXES, RESPECTIVELY, UNDER ARTICLE 81 OF THE ANNOTATED CODE OF MARYLAND, ENTITLED "REVENUE AND TAXES," AND THEY SHALL BOTH BE RECORDED IN THE OFFICE OF THE CLERK OF THE CIRCUIT COURT FOR CHARLES COUNTY.

C. REMOVAL FROM OFFICE OR EXPIRATION OF TERM; SUBSEQUENT PROCEDURES. SAID TREASURER SHALL BE SUBJECT AT ALL TIMES TO REMOVAL BY THE COUNTY COMMISSIONERS FOR WILLFUL NEGLECT OF DUTY OR MISDEMEANOR IN OFFICE, UPON CONVICTION IN A COURT OF LAW. IN THE EVENT OF REMOVAL FROM OFFICE, DEATH OR RESIGNATION DURING THE TERM OF OFFICE OF SAID TREASURER, THE COUNTY COMMISSIONERS SHALL AT ONCE APPOINT HIS SUCCESSOR, WHO SHALL QUALIFY AND BOND AS AFORESAID, AND SO CONTINUE TO APPOINT UNTIL A TREASURER QUALIFIES AS HEREIN PROVIDED, AND SUCH NEW TREASURER SHALL TAKE CHARGE OF AND COLLECT ALL TAXES THAT MAY BE IN THE HANDS OF THE LATE TREASURER UNCOLLECTED AND FOR WHICH THE LATE TREASURER WAS RESPONSIBLE AND, FOR SUCH UNCOLLECTED TAXES, SHALL GIVE A SEPARATE BOND IN SUCH PENALTY AS MAY BE
