

ANY OTHER BODY THAT MAY BE AUTHORIZED BY LAW TO GIVE SAID ORDERS, BY CHECK UPON SAID BANK OR TRUST COMPANY, SIGNED BY SAID TREASURER. IT SHALL BE IN THE POWER OF THE COUNTY COMMISSIONERS TO REQUIRE MONEY TO BE PAID BY THE TREASURER, AT ANY TIME HE MAY HAVE IT IN HIS POSSESSION OR DEPOSITED AS AFORESAID, FOR THE PAYMENT OF BILLS THAT MAY BE LEVIED AGAINST THE COUNTY, AND THE FAILURE OF THE TREASURER TO CONFORM TO THE REQUIREMENTS OF THE COUNTY COMMISSIONERS TO SUCH PAYMENT AS HEREIN SET FORTH SHALL SUBJECT SAID TREASURER TO A LIABILITY TO THE COUNTY FOR AN AMOUNT EQUIVALENT TO ALL SUCH MONEY THUS HELD BY HIM AND ORDERED TO BE PAID OVER AT SIX PERCENT (6%) PER ANNUM UNTIL IT SHALL BE SO PAID OVER AND ALSO A DEDUCTION OF ALL COMMISSION ON SAID MONEY UNTIL SAID REQUIREMENTS SHALL BE CARRIED OUT AS DESIGNATED BY THE COUNTY COMMISSIONERS. THE COUNTY COMMISSIONERS MAY, AT ANY TIME THEY SEE FIT, REQUIRE THE TREASURER TO REPORT TO THEM AS TO THE AMOUNT OF MONEY HELD OR DEPOSITED BY HIM AS TREASURER OR, IN OTHER RESPECTS, AS TO THE STATE OF HIS ACCOUNTS, AND THEY MAY ALSO REQUIRE FROM ANY BANK OR TRUST COMPANY WITH WHOM MONEY MAY BE DEPOSITED BY SAID TREASURER ANY SPECIAL AGREEMENT OR SECURITY, IN ADDITION TO THE CORPORATE LIABILITY OF THE BANK, FOR THE MONEY THUS DEPOSITED BY HIM.

136-10. ADVERTISEMENT AND PUBLIC NOTICE REQUIREMENTS.

A. NOTIFICATION REQUIREMENTS FOR TAX SALES; SALE PROCEDURES. NOTICE SHALL BE PUBLISHED IN NO FEWER THAN FOUR (4) WEEKLY INSERTIONS IN EACH OF THE NEWSPAPERS HEREINBEFORE REFERRED TO, AND ON SAID DAY, AT THE TIME NAMED, THE TREASURER SHALL PROCEED TO SELL ANY AND ALL SUCH PARCELS OF LAND, PREMISES AND PERSONAL PROPERTY ON WHICH TAXES, INTEREST, COSTS AND FEES SHALL NOT HAVE BEEN PAID AND SHALL CONTINUE SAID SALE EACH DAY, LEGAL HOLIDAYS EXCEPTED, FROM 10:00 A.M. UNTIL 3:00 P.M., UNTIL EVERY SUCH PARCEL OF LAND, PREMISES AND PERSONAL PROPERTY OR MORE THAN A SUFFICIENT QUANTITY TO PAY ALL TAXES, COSTS AND EXPENSES FOR EACH CASE SHALL HAVE BEEN OFFERED FOR SALE.

B. LEGAL COUNSEL; ADVERTISING AND NOTIFICATION REQUIREMENTS GENERALLY. THE COUNTY TREASURER SHALL NOT BE ALLOWED ANY EXPENDITURES FOR ATTORNEY'S FEES, BUT IT SHALL BE THE DUTY OF THE ATTORNEY TO THE COUNTY COMMISSIONERS TO ADVISE HIM AND ACT AS ATTORNEY FOR HIM IN ALL OF HIS OFFICIAL WORK REQUIRING THE ADVISE OR SERVICES OF AN ATTORNEY FOR HIM AS TREASURER. NO COMPENSATION SHALL BE CHARGED, ALLOWED OR PAID TO ANY PAPER OTHER THAN IS DESIGNATED BY THE COUNTY COMMISSIONERS AS HEREINBEFORE SET FORTH; PROVIDED, HOWEVER,
