(B) Notwithstanding the provisions of this section, the Corporation is not and may not be deemed a department, unit, agency, or instrumentality of the State.

[No action or proceeding shall be prosecuted or maintained against a] A member of a military court or officer or person acting under its authority, or reviewing its proceedings on account of the approval or imposition or execution of any sentence, or the imposition or collection of a fine or penalty, or the execution of any warrant, writ, execution, process or mandate of a military court SHALL HAVE THE IMMUNITY
