possesses a copy of the resident's official leave order.

- (c) A person RESIDENT with a basic hunting license shall obtain a deer stamp for a fee as provided in § 10-301(f)[(5)](6) of this subtitle. A person RESIDENT OR NONRESIDENT with a basic hunting license hunting deer during the bow hunting season shall obtain a special bow hunting deer stamp for a fee as provided in § 10-301(f)[(5)](6) of this subtitle. A person RESIDENT OR NONRESIDENT with a basic hunting license hunting deer with a muzzle loader during the muzzle loader deer season shall obtain a special black powder deer stamp for a fee as provided in § 10-301(f)[(5)](6) of this subtitle.
- (D) (1) A person may obtain the consolidated hunting license, the <u>RESIDENT</u> AND NONRESIDENT basic license, of AND individual hunting stamp from the clerk of the circuit court of any county or from any person designated by the Department.
- (2) The issuing clerk or person designated shall retain the sum of 50 cents as compensation for issuing each <u>RESIDENT AND NONRESIDENT</u> basic hunting license and an individual hunting stamp and \$1 as compensation for issuing each consolidated hunting license. The balance of the fee is paid over and accounted for in the same manner as hunting licenses.
- (3) The Department shall use \$1 from the sale of each consolidated hunting license and, except for the fee retained by the issuing clerk, all of the money derived from the sale of bow and arrow and black powder stamps to:
- (1) (I) Establish an effective and efficient deer checking system during the muzzle loader and bow hunting deer season;
- (2) (II) Acquire additional hunter access during the muzzle loader and bow hunting season; and
- (3) (III) Police hunting lands during the muzzle loader and bow hunting season.
- (d) (E) The court clerk or designated person shall write or stamp the date of issuance on the face of every consolidated hunting license, <u>RESIDENT AND NONRESIDENT</u> basic hunting license, and individual hunting stamp issued under this section. Each individual hunting stamp shall be affixed in the manner that the Department provides. The recipient shall sign the consolidated hunting license or <u>RESIDENT OR NONRESIDENT</u> basic hunting license in ink.

- (a) In addition to the consolidated hunting license, NONRESIDENT 3-DAY HUNTING LICENSE, or <u>RESIDENT OR NONRESIDENT</u> basic hunting license, a person hunting migratory wild waterfowl in the State first shall obtain a Maryland migratory wild waterfowl stamp.
 - (b) A Maryland migratory wild waterfowl stamp is not required of the following:
 - (1) The owner or tenant of farmland, the owner's or tenant's spouse and
