(III) 1 SHALL BE A RESIDENT OF ANY COUNTY IN THE AREA THAT CONSISTS OF BALTIMORE, CARROLL, HARFORD, AND HOWARD COUNTIES;

(IV) 1 SHALL BE A RESIDENT OF BALTIMORE CITY;

(V) 1 SHALL BE A RESIDENT OF ANY COUNTY IN THE AREA THAT CONSISTS OF ANNE ARUNDEL, CALVERT, CHARLES, PRINCE GEORGE'S, AND ST. MARY'S COUNTIES; AND

(VI) 1 SHALL BE A RESIDENT OF ANY COUNTY IN THE AREA THAT CONSISTS OF ALLEGANY, FREDERICK, GARRETT, MONTGOMERY, AND WASHINGTON COUNTIES.

(4) (I) THE GOVERNOR SHALL APPOINT THE MEMBERS WITH THE ADVICE OF THE SECRETARY AND WITH THE ADVICE AND CONSENT OF THE SENATE.

(II) THE GOVERNOR MAY NOT APPOINT MORE THAN 2 MEMBERS FROM ANY 1 REGION SPECIFIED IN PARAGRAPH (3) OF THIS SUBSECTION.

(B) EACH MEMBER OF THE COMMISSION SHALL BE A CITIZEN OF THE STATE.

(C) EACH REAL ESTATE APPRAISER MEMBER OF THE COMMISSION:

(1) SHALL HAVE BEEN A RESIDENT OF ANY OF THE COUNTIES
