

REVIEW OF A PROCEEDING BEFORE THE BOARD.

(F) A PERSON WHO ACTS IN GOOD FAITH AND WITHIN THE SCOPE OF JURISDICTION OF A DENTAL HYGIENIST REHABILITATION COMMITTEE IS NOT CIVILLY LIABLE FOR ANY ACTION AS A MEMBER OF THE DENTAL HYGIENIST REHABILITATION COMMITTEE OR FOR GIVING INFORMATION TO, PARTICIPATING IN, OR CONTRIBUTING TO THE FUNCTION OF THE REHABILITATION COMMITTEE.

(A) IN THIS SECTION, "DIETETIC REHABILITATION COMMITTEE" MEANS A COMMITTEE THAT:

- (1) IS DEFINED IN SUBSECTION (B) OF THIS SECTION; AND
- (2) PERFORMS ANY OF THE FUNCTIONS LISTED IN SUBSECTION ~~(C)~~ (D) OF THIS SECTION.

(B) FOR PURPOSES OF THIS SECTION, A DIETETIC REHABILITATION COMMITTEE IS A COMMITTEE OF THE BOARD OR A COMMITTEE:

- (1) COMPOSED EQUALLY OF MEMBERS OF:
 - 1. MARYLAND DIETETIC ASSOCIATION; AND
 - 2. AMERICAN NUTRITIONISTS ASSOCIATION;
- (2) RECOGNIZED BY THE BOARD; AND
- (3) ~~COMPOSED OF THAT INCLUDES BUT IS NOT LIMITED TO~~ DIETITIANS AND NUTRITIONISTS.

(C) A REHABILITATION COMMITTEE OF THE BOARD OR RECOGNIZED BY THE BOARD MAY FUNCTION:

- (1) SOLELY FOR THE BOARD; OR
- (2) JOINTLY WITH A REHABILITATION COMMITTEE REPRESENTING ANOTHER BOARD OR BOARDS.

~~(C)~~ (D) FOR PURPOSES OF THIS SECTION, A DIETETIC REHABILITATION COMMITTEE EVALUATES AND PROVIDES ASSISTANCE TO ANY DIETITIAN, NUTRITIONIST, AND ANY OTHER INDIVIDUAL REGULATED BY THE BOARD IN NEED OF TREATMENT AND REHABILITATION FOR ALCOHOLISM, DRUG ABUSE, CHEMICAL DEPENDENCY, OR OTHER PHYSICAL, EMOTIONAL, OR MENTAL CONDITION.

~~(D)~~ (E) (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, THE PROCEEDINGS, RECORDS, AND FILES OF THE DIETETIC REHABILITATION COMMITTEE ARE NOT DISCOVERABLE AND ARE NOT ADMISSIBLE IN EVIDENCE IN ANY CIVIL ACTION ARISING OUT
