(3) FOR PURPOSES OF THIS SUBSECTION, CIVIL ACTION DOES NOT INCLUDE A PROCEEDING BEFORE THE BOARD OR JUDICIAL REVIEW OF A PROCEEDING BEFORE THE BOARD.

~~(E)~~ (F) A PERSON WHO ACTS IN GOOD FAITH AND WITHIN THE SCOPE OF JURISDICTION OF A DIETETIC REHABILITATION COMMITTEE IS NOT CIVILLY LIABLE FOR ANY ACTION AS A MEMBER OF THE DIETETIC REHABILITATION COMMITTEE OR FOR GIVING INFORMATION TO, PARTICIPATING IN, OR CONTRIBUTING TO THE FUNCTION OF THE DIETETIC REHABILITATION COMMITTEE.

(A) IN THIS SECTION, "ELECTROLOGIST REHABILITATION COMMITTEE" MEANS A COMMITTEE THAT:

(1) IS DEFINED IN SUBSECTION (B) OF THIS SECTION; AND

(2) PERFORMS ANY OF THE FUNCTIONS LISTED IN SUBSECTION ~~(C)~~ (D) OF THIS SECTION.

(B) FOR PURPOSES OF THIS SECTION, AN ELECTROLOGIST REHABILITATION COMMITTEE IS A COMMITTEE OF THE BOARD OR A COMMITTEE OF ANY ASSOCIATION REPRESENTING ELECTROLOGISTS THAT:

~~(1) APPOINTED BY THE SECRETARY, IN CONSULTATION WITH:~~

~~1. THE BOARD; AND~~

~~2. ANY ASSOCIATION REPRESENTING ELECTROLOGISTS;~~

AND

~~(2) COMPOSED OF ELECTROLOGISTS.~~

(1) IS RECOGNIZED BY THE BOARD; AND

(2) INCLUDES BUT IS NOT LIMITED TO ELECTROLOGISTS.

(C) A REHABILITATION COMMITTEE OF THE BOARD OR RECOGNIZED BY THE BOARD MAY FUNCTION:

(1) SOLELY FOR THE BOARD; OR
