TITLE 7. HOUSING AUTHORITY OF ANNE ARUNDEL COUNTY AND

7-101.

TITLE 1 OF THIS ARTICLE SHALL APPLY TO THE HOUSING AUTHORITY OF ANNE ARUNDEL COUNTY ~~AND HOUSING AUTHORITIES IN ANNE ARUNDEL COUNTY~~ TO THE EXTENT IT IS NOT INCONSISTENT WITH THIS TITLE.

7-102.

NOTWITHSTANDING §§ 1-202 THROUGH 1-204 OF THIS ARTICLE, FROM AND AFTER JULY 1, 1977, THE HOUSING AUTHORITY OF ANNE ARUNDEL COUNTY SHALL BE COMPOSED OF 7 PERSONS. THE 5 PERSONS SERVING AS COMMISSIONERS OF THE AUTHORITY ON JULY 1, 1977 SHALL CONTINUE TO SERVE UNTIL THEIR RESPECTIVE TERMS EXPIRE AND THEIR SUCCESSORS HAVE BEEN APPOINTED AND QUALIFIED. THE COUNTY EXECUTIVE SHALL DESIGNATE 2 ADDITIONAL PERSONS TO SERVE AS COMMISSIONERS, 1 OF WHOM SHALL BE APPOINTED FOR A TERM OF 1 YEAR AND THE OTHER FOR A TERM OF 2 YEARS, FROM THEIR RESPECTIVE DATES OF APPOINTMENT. THEREAFTER THEIR SUCCESSORS SHALL BE APPOINTED FOR TERMS OF 5 YEARS EACH EXCEPT THAT VACANCIES SHALL BE FILLED FOR THE UNEXPIRED TERM.

TITLE 8. HOUSING AUTHORITIES IN SOMERSET COUNTY

8-101.

TITLE 1 OF THIS ARTICLE SHALL APPLY TO SOMERSET COUNTY TO THE EXTENT IT IS NOT INCONSISTENT WITH THIS TITLE.

8-102.

NOTWITHSTANDING § 1-207(B) OF THIS ARTICLE, IN SOMERSET COUNTY, MEMBER OF THE COUNCILS OF INCORPORATED CITIES MAY SERVE AS COMMISSIONERS OF THE HOUSING AUTHORITY OF THEIR CITY.

TITLE 9. INDIAN HOUSING AUTHORITIES

9-101.

TITLE 1 OF THIS ARTICLE SHALL APPLY TO INDIAN HOUSING AUTHORITIES TO THE EXTENT IT IS NOT INCONSISTENT WITH THIS TITLE.

9-102.

(A) ANY INDIAN TRIBE MAY ESTABLISH A HOUSING AUTHORITY UPON APPROVAL BY ORDINANCE OR RESOLUTION OF THE GOVERNING BODY AND CHIEF ELECTED OFFICIAL OF THE LOCAL JURISDICTION
