REPORTS EACH PANEL REPORT TO THE GOVERNOR AND THE LEGISLATIVE POLICY COMMITTEE TO ALLOW TIME FOR CONSIDERATION OF THE PANEL'S REPORT AND ACTIONS AT THE ENSUING SESSION OF THE GENERAL ASSEMBLY;

- (5) TRANSMIT THE PANELS' REPORTS TO ANY STATE AGENCY THAT IS IDENTIFIED AS BEING AFFECTED BY THE LEGISLATIVE PROPOSAL OR STATUTE UNDER REVIEW; AND
- (6) ADMINISTER THE BUSINESS OF THE COMMITTEE AND THE PANELS.
- (F) (1) (I) THE PANEL SHALL CONSIST OF OBJECTIVE EXPERT PERSONNEL SELECTED FROM AMONG PERSONS WHO ARE SKILLED IN HEALTH RESEARCH, ECONOMICS, STATISTICS, OR ACTUARIAL SCIENCE, AND MAY INCLUDE HEALTH CARE PROVIDERS OR PRACTITIONERS.
- (II) THE PANELS MAY CONSIST OF EXISTING LEGISLATIVE, EXECUTIVE, OR INSTITUTIONAL STAFF OR, WHEN APPROPRIATE, OUTSIDE EXPERTS.

(II) THE PANELS SHALL CONSIST OF:

- 1. EXISTING LEGISLATIVE, EXECUTIVE, OR STATE INSTITUTIONAL STAFF AND AN OUTSIDE EXPERT OR EXPERTS; OR
 - 2. OUTSIDE EXPERTS.
 - (2) THE PANEL SHALL:
- (I) COLLECT AND ANALYZE DATA AND INFORMATION CONCERNING THE SUBJECT ASSIGNED TO IT FOR REVIEW;
- (II) CONDUCT AN EVALUATION OF THE STATUTE OR LEGISLATIVE PROPOSAL ASSIGNED TO IT FOR REVIEW, INCLUDING THE SOCIAL AND FISCAL COSTS AND BENEFITS; AND

(III) BASED ON DATA SUBMITTED:

- 1. REPORT ON WHETHER SUFFICIENT DATA EXISTS TO MAKE AN EVALUATION;
- 2. RECOMMEND THE REPORTING AND COLLECTION OF STATISTICS AND DATA NEEDED TO EVALUATE THE MANDATED HEALTH INSURANCE BENEFIT OR, NONDISCRIMINATION PROVISION, AND BENEFICIARY OR LENGTH OF COVERAGE PROVISIONS;
- 3. RECOMMEND CHANGES ANALYZE POSSIBLE MODIFICATIONS TO EXISTING OR PROPOSED MANDATED HEALTH INSURANCE BENEFITS OR, NONDISCRIMINATION PROVISIONS, AND BENEFICIARY OR LENGTH OF COVERAGE PROVISIONS;
