

SECTION SHALL BECOME EFFECTIVE IN ACCORDANCE WITH TITLE 10, SUBTITLE 1 OF THE STATE GOVERNMENT ARTICLE, UNLESS THE BOARD IS NOTIFIED BY THE STATE BOARD OF EDUCATION OF ITS OBJECTION TO THE ADOPTION OF SUCH REGULATIONS WITHIN 60 DAYS AFTER SUBMISSION TO THE STATE BOARD OF EDUCATION.

2. OBJECTIONS BY THE STATE BOARD TO THE ADOPTION OF REGULATIONS ADOPTED UNDER THIS SUBSECTION SHALL BE IN WRITING AND SHALL CONTAIN A STATEMENT OF THE REASONS FOR OBJECTION.

3. THE BOARD SHALL CONSIDER SUCH OBJECTIONS AND MAY RESUBMIT TO THE STATE BOARD ANY REGULATIONS SO RECONSIDERED.

~~(III)~~ (IV) NO REGULATION MAY BECOME EFFECTIVE UNTIL THERE IS A CONCURRENCE BY BOTH THE BOARD AND APPROVAL FROM THE STATE BOARD OF EDUCATION.

(2) AN INDIVIDUAL WHO IS OTHERWISE QUALIFIED MAY NOT BE DENIED THE RIGHT TO RECEIVE CREDENTIALS FROM THE BOARD, TO RECEIVE TRAINING TO BECOME A TEACHER, OR TO PRACTICE TEACHING IN ANY SCHOOL BECAUSE THAT INDIVIDUAL IS TOTALLY OR PARTIALLY BLIND.

(3) A COUNTY BOARD MAY NOT REFUSE TO CONTRACT WITH OR ENGAGE A TEACHER BECAUSE OF BLINDNESS IF THE BLIND TEACHER IS CAPABLE OF PERFORMING THE DUTIES OF THE POSITION FOR WHICH HE HAS APPLIED.

(4) THE RIGHT OF A SCHOOL PSYCHOLOGIST, WHO IS CERTIFIED BY THE BOARD TO PRACTICE SCHOOL PSYCHOLOGY CONSISTENT WITH THE PROVISIONS OF THAT CERTIFICATION, MAY NOT BE LIMITED BY TITLE 16 OF THE HEALTH OCCUPATIONS ARTICLE WITH RESPECT TO THE PRACTICE OF SCHOOL PSYCHOLOGY IN AN EDUCATIONAL INSTITUTION.

(B) (1) THE BOARD MAY ESTABLISH A FEE, NOT TO EXCEED \$10, FOR ISSUANCE OR RENEWAL OF A TEACHER CERTIFICATE.

(2) THE BOARD MAY NOT REQUIRE A FEE:

(I) FOR THE ADDITION OF ANY NEW AREA OF CERTIFICATION TO A CURRENTLY VALID CERTIFICATE; OR

(II) EXCEPT FOR THE FEE AUTHORIZED UNDER PARAGRAPH (1) OF THIS SUBSECTION, FOR THE EVALUATION OF CREDENTIALS FOR THE CERTIFICATION OF TEACHERS.
