(D) THE REGISTRATION OF A NURSING STAFF AGENCY EXPIRES:

(1) 3 YEARS AFTER ITS EFFECTIVE DATE, UNLESS RENEWED FOR AN ADDITIONAL 3-YEAR TERM; OR

(2) WHEN THE CONTROLLING OWNERSHIP INTEREST IS TRANSFERRED TO ANOTHER PERSON, FIRM, CORPORATION, PARTNERSHIP, OR OTHER BUSINESS ENTITY.

(1) ENSURE THAT ALL NURSING PERSONNEL PROCURED, FURNISHED, OR REFERRED TO A HEALTH CARE FACILITY BY THE NURSING STAFF AGENCY ARE CURRENTLY LICENSED BY THE BOARD OF NURSING AS A:

(I) LICENSED PRACTICAL NURSE; OR

(II) REGISTERED NURSE;

(2) MAINTAIN LIABILITY INSURANCE FOR THE NURSING STAFF AGENCY;

(3) NOTIFY A HEALTH CARE FACILITY BEFORE ANY NURSE IS PROCURED, FURNISHED, OR REFERRED TO THE HEALTH CARE FACILITY WHETHER THE NURSE BEING PROCURED, FURNISHED, OR REFERRED IS CURRENTLY COVERED BY A PROFESSIONAL LIABILITY INSURANCE POLICY;
