vocational education on the staffs of Boys' Village of Maryland, Charles H. Hickey, Jr. School, Montrose School, and any and all other institutions which are under the supervision, direction, control and general management of the Department of Juvenile Services;

- (16) Any position that, under Subtitle 5A of Title 2 of the Courts and Judicial Proceedings Article, is subject to the personnel merit system for the Circuit Court for Baltimore City;
- (17) All positions the annual salary for which does not exceed the sum of six hundred and fifty dollars (\$650) per annum; [and]
- (18) Administrative law judges appointed under Title 9, Subtitle 16 of the State Government Article; AND
- (19) ALL OFFICERS AND FACULTY OF THE COMMUNITY COLLEGE OF MARYLAND AT BALTIMORE NEW COMMUNITY COLLEGE OF BALTIMORE AND ALL REGISTRARS AND LIBRARIANS DESIGNATED BY THE BOARD OF TRUSTEES OF THE COMMUNITY COLLEGE OF MARYLAND AT BALTIMORE NEW COMMUNITY COLLEGE OF BALTIMORE AS HOLDING FACULTY RANK.

Article 73B - Pensions

- (A) (1) IN THIS SECTION "FORMER CCB EMPLOYEE" MEANS A PERSON WHO WAS AN EMPLOYEE OF THE COMMUNITY COLLEGE OF BALTIMORE AS OF JUNE 1, 1990 DURING THE MOST RECENT ACADEMIC YEAR AND WHO WAS SUBSEQUENTLY EMPLOYED BY THE NEW COMMUNITY COLLEGE OF BALTIMORE BEFORE DECEMBER 31, 1990 ON OR BEFORE DECEMBER 31, 1990.
- (2) NOTWITHSTANDING PARAGRAPH (1) OF THIS SUBSECTION, "FORMER CCB EMPLOYEE" INCLUDES THE PRESIDENT AND VICE-PRESIDENTS OF THE COMMUNITY COLLEGE OF BALTIMORE.
- (B) (1) EXCEPT AS OTHERWISE PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, EACH NEW PROFESSIONAL OR CLERICAL EMPLOYEE OF THE NEW COMMUNITY COLLEGE OF BALTIMORE SHALL BECOME A MEMBER OF THE PENSION SYSTEM FOR TEACHERS OF THE STATE OF MARYLAND AS A CONDITION OF EMPLOYMENT UNLESS THE EMPLOYEE, IF OTHERWISE ELIGIBLE, ELECTS TO PARTICIPATE IN AN OPTIONAL RETIREMENT PROGRAM PROVIDED IN ACCORDANCE WITH § 110 OF THIS ARTICLE.
- (2) A FORMER CCB EMPLOYEE WHO, AT THE TIME OF EMPLOYMENT BY THE NEW COMMUNITY COLLEGE OF BALTIMORE, IS A MEMBER OF THE TEACHERS' RETIREMENT SYSTEM OF THE STATE OF MARYLAND, SHALL REMAIN A MEMBER OF THAT RETIREMENT SYSTEM UNLESS AND UNTIL THE EMPLOYEE FILES WITH THE BOARD OF
