

this process fully inform and strongly encourage needed faculty and other needed employees to remain with the New Community College of Baltimore.

SECTION 10. AND BE IT FURTHER ENACTED, That the City of Baltimore shall expend at least \$300,000 in each fiscal year for tuition reimbursement or scholarships to attend classes at the New Community College of Baltimore.

SECTION 11. AND BE IT FURTHER ENACTED, That ~~the State is not~~ neither the State, nor the Board of Trustees of the New Community College of Baltimore, nor the New Community College of Baltimore is responsible for any judgment, obligation, damage, or liability arising from any employment act, occurrence, or transaction taken by the Community College of Baltimore, the Board of Trustees of the Community College of Baltimore, the City of Baltimore, or their agents.

SECTION 12. AND BE IT FURTHER ENACTED, That, notwithstanding § 7-236 of the State Finance and Procurement Article and notwithstanding Section 16 of the State Budget, the Secretary of Budget and Fiscal Planning is authorized to fix the number and class of positions, including temporary and permanent positions, or man years, not inconsistent with the public general laws in regard to classification, for the New Community College of Baltimore. Payment for salaries or wages or any request for or certification of personnel may not be made except in accordance with the determinations of the Secretary. At any time during the fiscal year, the Secretary may amend the number and classes of positions or man years of employment previously fixed by the Secretary. The Secretary may delegate all or part of this authority to transfer positions between programs and campuses without the approval of the Secretary, as provided in § 15-105 of the Education Article. Positions created for the New Community College of Baltimore may not be used for or transferred to any other agency or unit of State government.

SECTION 13. AND BE IT FURTHER ENACTED, That the terms of office of the current members of the Board of Trustees of the Community College of Baltimore shall terminate as of ~~July 1, 1990~~ December 31, 1990. The Board of Trustees of the Community College of Baltimore shall continue in existence from July 1, 1990 through December 31, 1990 for the sole purposes of carrying out the provisions and purposes of this Act and closing out the affairs of the Community College of Baltimore.

SECTION 14. AND BE IT FURTHER ENACTED, That before July 1, 1990, the Board of Trustees shall submit to the Maryland Higher Education Commission and the Department of Budget and Fiscal Planning for their approval a proposed budget that shows, in the form and detail specified by the Department, the proposed apportionment and disbursement of all revenue sources. Except for amendments approved in accordance with § 7-209 of the State Finance and Procurement Article, expenditures and disbursements shall be made in accordance with the approved budget.

SECTION 15. AND BE IT FURTHER ENACTED, That in order to carry out the provisions of this Act, by July 1, 1990, the Secretary of Budget and Fiscal Planning shall transfer to the Board of Trustees of the New Community College of Baltimore any funds appropriated for the use of the College. Additionally, effective July 1, 1990, all grants, awards, memberships, and any other funds of and for the use of the Community
