

(G) "SMALL BUSINESS" MEANS A BUSINESS, INCLUDING A FARM BUSINESS, THAT HAS ASSETS, INCOME, OR EMPLOYEES THAT DO NOT EXCEED LIMITS ESTABLISHED BY THE SECRETARY OF ECONOMIC AND EMPLOYMENT DEVELOPMENT.

(H) "TRUSTEES" MEANS THE MEMBERS OF THE BOARD, WHICH PERSONS MAY BE DIRECTORS OR TRUSTEES OR HAVE SUCH OTHER LEGAL STATUS REQUISITE OR APPROPRIATE TO THE TYPE OF ENTITY CONSTITUTING THE FUND.

(A) (1) THE DEPARTMENT SHALL ENCOURAGE AND TAKE ANY NECESSARY OR PROPER ACTIONS TO FACILITATE THE CREATION OF THE COMMUNITY REINVESTMENT FUND.

(2) THE DEPARTMENT SHALL ~~ASSIST~~ PROVIDE TECHNICAL ASSISTANCE IN THE FORMATION OF THE FUND.

(3) THE DEPARTMENT MAY PROVIDE FUNDS FOR ORGANIZATIONAL EXPENSES OF THE FUND, INCLUDING ADMINISTRATIVE, LEGAL, AND OTHER EXPENSES INCURRED IN FORMING THE PRIVATE AND INDEPENDENT LEGAL ENTITY CONSTITUTING THE FUND.

(B) (1) THE DEPARTMENT AND THE DEPARTMENT OF ECONOMIC AND EMPLOYMENT DEVELOPMENT MAY PROVIDE TECHNICAL ASSISTANCE:

(1) ~~ASSIST IN OR PROVIDE FUNDS~~ (I) FOR THE ONGOING OPERATION AND ADMINISTRATION OF THE FUND;

(2) ~~ASSIST~~ (II) IN THE UNDERWRITING OF PROPOSED COMMUNITY REINVESTMENT PROJECTS; AND

(3) (2) THE DEPARTMENT AND THE DEPARTMENT OF ECONOMIC AND EMPLOYMENT DEVELOPMENT MAY CHARGE SUCH FEES AS ARE REASONABLE AND CUSTOMARY FOR THE PROVISION TO THE FUND OF ASSISTANCE UNDER THIS SUBSECTION.

(A) (1) THE PURPOSE OF THE FUND IS TO ADMINISTER THE USE AND REINVESTMENT OF MONEYS THAT MAY BE CREDITED, PAID, OR OTHERWISE TRANSFERRED TO THE FUND FROM ANY PERSON OR ENTITY APPROVED FOR PARTICIPATION IN THE FUND BY THE BOARD, INCLUDING BANKS, SAVINGS INSTITUTIONS, AND OTHER FINANCIAL INSTITUTIONS.

(2) THE MONEYS ADMINISTERED BY THE FUND SHALL BE USED TO PROVIDE COMMUNITY REINVESTMENT ASSISTANCE IN
