1. Be it enacted by the General Assembly of Maryland, That the justices of the levy court of Baltimore county be and they are hereby authorised and empowered, to appoint from time to time a treasurer for said county, being a citizen of said county, who shall hold his office at the pleasure of said justices, and who, before he enters on the duties of said office, shall give bond to the state of Maryland in the sum of twenty thousand dollars, with two securities to be approved and accepted by said justices, conditioned for the faithful performance of his duties as treasurer of said county, and for the payment over of all monies, and delivery of all books and papers, that shall come to his hands or possession as treasurer aforesaid, to such person or persons as the justices of the levy court of Baltimore county shall direct or require; and the justices aforesaid may allow said treasurer, as a compensation for his services, a sum not exceeding five hundred dollars per annum, and they may require him to give a new bond, with other or additional securities, whenever they shall deem the same necessary.
