1800 tickets were to be sold at 10 shillings each yielding a total of £900 of which £420 were to be given in prizes and the remainder to be used for the bridge. After three months all unredeemed prizes were to be considered a donation. The judges and managers were Rev. Thomas McPherrin, John Barnes, Esquire, Melcher Beltzhoover, Baltzer Goll, Martin Kershner, Adam Ott, Esquire, and Richard Cromwell. Dated Elizabeth-town, March 12, 1790.
