Most of the papers fall within the period 1741-1766, although there are a few items dated later, including a small group of items relating to Mrs. Callister's School, 1783-1788. Callister had a wide correspondence and such prominent Maryland names as Tilghman, Lloyd, Goldsborough, Bordley and Hollyday appear frequently among these papers.

Our collection of family *Bible* records was enriched by items relating to the Backer, Deaver, Gaither, Hill, Horsey, McKenney and Tull families.
