No. 1. An act to grant and declare the sanction and consent of the General Assembly of Maryland to a sale and conveyance by John M. Glenn and William L. Glenn to The Vestry of the Church of the Atonement in Baltimore city, of a certain lot of ground in Baltimore city, and to the holding of said lot by the said The Vestry of the Church of the Atonement in Baltimore city, in fee simple, with full power to dispose of the same.....	8
No. 2. An act to authorize the Mayor and Council of Salisbury, Wicomico County, to purchase a site for a fire engine house and to erect a house on the same, and authorize the issuing of bonds for defraying the cost of said lot and house.....	4
No. 3. An act to authorize and require the County Commissioners of Frederick County to pay to the Burgess and Commissioners of Middletown, a proportion of the franchise tax paid by the savings banks and other institutions and corporations located within the taxable limits of Middletown in said county.....	5
No. 4. An act to repeal chapter three hundred and forty-six of the Acts of the General Assembly of Maryland, passed at the January session, in the year eighteen hundred and ninety, entitled an act to repeal sections two hundred and eighty-nine of article eleven of the Code of Public Local Laws of the State of Maryland, title "Frederick County," sub-title "Justices of the Peace and Constables," and re-enact the same with an amendment, relating to the number of Justices of the Peace and Constables in Frederick county, and to re-enact the same with amendments.....	5
No. 5. An act to sanction the bequest of two thousand dollars to the Trustees of the Madison Street Presbyterian Church of Baltimore, contained in the last will and testament of John Plyman, late of Baltimore city.....	7
No. 6. An act to repeal chapter 275 of the acts of 1894, entitled "An act to repeal sections 74, 75, 76, 77, 78 and 79 of article 5 of the Code of Public Local Laws, title 'Calvert County,' sub-title 'fences,'" and to re-enact said sections under the said title and sub-title.....	7
No. 7. An act to prohibit the sale of spirituous or fermented liquors, or lager beer at any place in Garrett county within two miles of Anderson Chapel, in the village of Swanton, Garrett county, Maryland.....	9
No. 10. An act to require the County Commissioners of Carroll County to pay to the Mayor and Common Council of Manchester, one-half of the amount of road tax levied or taxed upon the property within the limits of the town of Manchester.....	10
No. 11. An act to authorize and empower the Commissioners of Thurmont to borrow money necessary to pay a mortgage on the town hall property, not exceeding the sum of fifteen hundred dollars, and to issue bonds therefor.....	10
No. 12. An act to appropriate a sum of money out of the treasury of the State, not otherwise appropriated, to reimburse William C. Legg, late collector of taxes for the fourth election district of Queen Anne's County, for money erroneously paid into the State treasury.....	12
