No. 161. An act to amend the charter and to extend the powers of the Mount Washington Electric Light and Power Company of Baltimore County, a corporation formed under article twenty-three of the Code of Public General Laws of Maryland, entitled "Corporations.".....	251

An act to ratify and confirm certain privileges heretofore granted by the County Commissioners for Baltimore county unto the Baltimore, Middle River and Sparrows Point Railroad, and to grant other privileges to said railroad, for the use of other roads and streets in Baltimore county.....	253

An act to add a new section to article 17 of the Code of Public General Laws of Maryland, title "Clerks of Courts," sub-title "Clerk of the Court of Appeals," to come in after section 40, and to be known as "Section 40A," making an annual appropriation for the payment of the annual expenses of the clerk of the Court of Appeals; and an annual appropriation for the payment of the costs incurred by the State for printing all records and briefs in State cases in the Court of Appeals.....	258

An act to repeal and re-enact with amendments section two of article eighty-one, of the Code of Public General Laws, title "Revenue and Taxes," sub-title "Rate and Items of State Tax," as the said section was amended by the act of 1894, chapter 285, entitled an act to regulate the levy for State purposes for the year eighteen hundred and ninety-four and subsequent years.....	259

An act to repeal chapter 391 of the acts of the General Assembly of Maryland, session of 1892, and to provide for the issue of five hundred thousand dollars, Maryland State bonds, to be used for the purpose of construction and equipment of the extension of the Maryland Penitentiary, at a rate not higher than 3.65 per centum interest per annum, and to provide a sinking fund for the payment of said bonds.....	260
