An Act to authorize and empower the Mayor and Council of Pocomoke City, in Worcester County, to issue and sell bonds of the said town to the amount of thirteen thousand dollars for the payment of indebtedness of the said town contracted for repairing the fire engine and supplying additional fire hose, and for the payment at maturity of the bonds of the said town issued under authority conferred by Section 26 of Chapter 189 of the Laws of Maryland, passed at the January Session of 1892, as amended by Chapter 226 of the Laws of Maryland, passed at the January Session of 1894, and to provide for the levy and collection of taxes to meet the interest and principal of said bonds.....	131
