An Act to provide for the issue of six hundred thousand dollars Maryland State bonds for the purpose of erecting an addition to the State House, in the City of Annapolis, for the removal and demolition of the State Library building and the annexes thereto, and for the purchase of a lot of ground and the construction thereon of a plant for the heating of all the State buildings in Annapolis, and for furnishing said State buildings, and for the completion of the Fifth Regiment Armory, and the construction of an annex to the Maryland House of Correction; said bonds to bear a rate of interest not higher than three and one-half per cent. per annum, and to provide for a sinking fund for the payment of said bonds.....	306
