No. 397. An Act to add a new paragraph to Section 6 of Article 4, entitled "City of Baltimore," of the Code of Public Local Laws of Maryland, to come in immediately after the conclusion of the paragraph in said section, entitled "Condemnation of Property," and to be entitled "Condemnation of Property for Esplanades and the like".....	715
No. 398. An Act to repeal and re-enact with amendments Section 8 of Article 68 of the Code of Public General Laws of Maryland, titled "Notaries Public".....	716
No. 399. An Act to amend Article 8 of the Code of Public General Laws, title "Assignment of Choses in Action," by adding thereto certain sections, to follow Section 10 of said Article, and to be known as Sections 11, 12, 13, 14, 15, 16, 17 and 18.....	717
No. 401. An Act to create a Paving Commission for the city of Baltimore, and to define its duties and powers; to authorize the Mayor and City Council of Baltimore to issue stock to an amount not exceeding five million (\$5,000,000) dollars for the purpose of defraying the cost of the work of said commission; to provide for the submission of an ordinance to that end to the legal voters of the city of Baltimore; and to empower the Mayor and City Council of Baltimore to assess the cost of any work of said commission in part, upon the property bounding upon any public lane, alley, avenue, street or highway in the city of Baltimore, upon which such work shall be done by said commission, and to collect and make use of such assessments for the purposes of this Act.....	719

An Act to amend Article 4 of the Code of Public Local Laws of Maryland, title "City of Baltimore," as the same was enacted by Chapter 123 of the Acts of the General Assembly of Maryland, passed in the year 1898, by adding a new section thereto, to be included in Section 6, title "General Powers," and to follow immediately after the sub-title "Condemnation of Property," said new section to provide for the assessment of benefits on property benefited by the establishment or enlargement of parks, squares, gardens or other public places.....	728
No. 403. An Act to add two new sections to Article 27 of the Code of Public General Laws, title "Crimes and Punishments," to be known as sub-title "Process against Corporations in Criminal Cases," to be known as Sections 651 and 652, and to follow Section 650 of Poe's Code of 1904.....	729
No. 404. An Act to repeal and re-enact with amendments Section 22 of Article 81 of the Code of Public General Laws, title "Revenue and Taxes," sub-title "Rate and Items of State tax," as said Section was amended by the Acts of the General Assembly of 1904, Chapter 343.....	731
No. 405. An Act to incorporate the Easton Banking and Trust Company.....	732
No. 406. An Act to repeal and re-enact with amendments Chapter 54 of the Acts of the General Assembly of Maryland, passed at the present Session, 1906, entitled "An Act to authorize the County Commissioners of Anne Arundel county to erect and establish a free bridge over Tracey's creek, in the Eighth Election District of said county, and for the necessary roads leading to the same, for the convenience of public travel".....	738
