No. 712. An Act to repeal Section 164 of Article 81 of the Code of Public General Laws of Maryland (as legalized by the Act of 1904, Chapter 72), title "Revenue and Taxes," sub-title "Tax on Gross Receipts of Certain Corporations," as said section was enacted by the Act of the General Assembly of 1896, Chapter 120, Section 1, Code Section 164, and to re-enact the said section with amendments.....	1196
No. 714. An Act to incorporate the Penn-Garrett Coal Mining Company of Garrett County, Maryland.....	1198
No. 715. An Act to sanction the bequest of the General Assembly of Maryland to the devise in the last will and testament of James M. Lowe, late of Talbot county, deceased, to the St. Michael's and Bay Side Methodist Protestant Churches of the Maryland Conference.....	1202
No. 716. An Act to repeal Sections 124 and 125 of Article 21 of the Code of Public Local Laws of Maryland, title "Talbot County," sub-title "Liquors and Intoxicating Drinks," and to repeal Section 126 of said Article 21, as the same was repealed and re-enacted with amendments by Chapter 584 of the Acts of 1900 of the General Assembly of Maryland; and to repeal Section 127 of said Article 21, as the same was repealed and re-enacted with amendments by Chapters 84 and 265 (duplicate Acts) of the Acts of 1902, of the General Assembly of Maryland; and to repeal Chapter 585 of the Acts of 1900 of the General Assembly of Maryland, said Act adding a new section to said Article 21, known as Section 127 A; and to repeal Sections 127 A and 127 B of Chapter 84 and of Chapter 265 (duplicate Acts) of the Acts of 1902 of the General Assembly of Maryland; and to enact in lieu of said sections four sections to be numbered 124, 125, 126 and 127 of the said Article 21 of the Code of Public Local Laws of Maryland, title "Talbot County," and to be and come under the sub-title "Liquors and Intoxicating Drinks," and being an Act to prohibit by uniform laws the sale of intoxicating liquors in Talbot county.....	1202
No. 717. An Act to add an additional section to Article 23 of the Code of Public General Laws of Maryland, title "Corporations," sub-title "Railroad Companies," said additional section to be known as Section 300 A, and to follow Section 300 of the said Article.....	1205
No. 718. An Act to amend the Act of the General Assembly of Maryland of 1886, Chapter 467, amending the Act of 1799, (November Session), Chapter 44, relating to the Benevolent Society of the city and county of Baltimore.....	1205
