No. 791, folio 205; Second, a deed from the Gerard Life Insurance, Annuity and Trust Company of Philadelphia, trustee, and Mary Powers Harris, curator, to the Vestry of the Bishop Cummins Memorial Church of the City of Baltimore, a body corporate, dated October 25, 1881, and recorded among the Land Records of Baltimore City, in Liber F. A. P., No. 909, folio 434.

To the bequest contained in the last will and testament of Emilie Schuchart, late of Baltimore City, deceased, probated in the Orphans' Court of Baltimore City, and of record in the office of the Register of Wills of said city, to Reverend D. H. Steffens, the pastor of Martini Evangelical Lutheran Church, located at the corner of Sharp and Henrietta streets, Baltimore, Maryland, the sum of fifty (\$50) dollars.

29. To the bequest contained in the last will and testament of William H. Dill, late of Baltimore City, deceased, probated in the Orphans' Court of Baltimore City, and of record in the office of the Register of Wills of said city, to the First German Evangelical Church (Greene Street Church), Baltimore, Maryland, the sum of fifty (\$50) dollars.
