(f) To the bequest of five hundred dollars to the Bowery Mission of New York City, conducted by Dr. Klapsch and Mrs. Bird. (g) To the bequest of five hundred dollars to the President and Managers of the Baltimore General Dispensary of Baltimore City, located at 651 West Lexington street, Baltimore, Maryland. (h) To the bequest of five hundred dollars to the Children's Fresh Air Society of Baltimore City. (i) To the bequest of one-seventh of the residue of the estate of said Lydia C.
