**COLORED TRAINING SCHOOL, MOUNT AND SARATOGA STS.
BALTIMORE, MD.**

This school prepares teachers for the elementary public schools of Baltimore City. Since it was established in 1900, it has prepared more than 400 teachers for the Baltimore School System.

The course of study is two years in length and is based upon an approved four year high school course.

The required subjects include psychology, history of education, theory of teaching, hygiene, manual training, physical training, drawing, music and the special methods of teaching history, geography, nature study, language, grammar and composition, reading and literature.

One-fourth of the course, one-half year, is devoted to practice teaching under criticism. During this time the pupil teacher receives compensation at the rate of one dollar per day.

The Board of Public School Commissioners awards a diploma to those students who complete the course in a satisfactory manner.

Graduates of this school are exempt from the academic examination prescribed by the Department of Education for untrained candidates. All candidates for positions in the elementary schools of Baltimore must pass a medical examination, and must also pass a professional examination in all the subjects named above except manual training, music, physical training, hygiene and drawing. In this examination a general average of at least 75% with no mark below 50% is the requirement.

Candidates who meet the above requirements and who show that they can teach and discipline are made Substitutes of Class I for one year, the salary for this period being \$600.00. If the work of the candidate for this probationary year is found satisfactory, he is elected at a salary of \$700.00 for the first year, and receives annual increases as prescribed by the rules of the Board of Education.

Tuition is free to residents of Baltimore. Other students are required to pay an annual tuition fee of about \$42.00. No charge is made for books or other material required in the course.
