- 26. To the devise and bequest contained in the will of James Benson, late of Talbot County, deceased, dated July 2, 1887, to Sardis Chapel of the Methodist Episcopal Church of the Wilmington Conference of the remainder of his estate, upon the death of certain persons named in said will, without issue surviving them.
- To the bequest contained in the last will and testament and codicil of John K. McCulloh, late of Bedford, Pennsylvania, deceased, of two parts or shares of the rest and remainder of his estate, which is divided into eighteen equal parts or shares, to the Preachers' Aid Society Baltimore Conference of the Methodist Episcopal Church, said will and codicil bearing date October 9, 1882, and recorded in the office of the Register of Wills for Bedford County, in the State of Pennsylvania, in Wills Book No. 6 page 58, etc. and a duplicate copy thereof taken from said record was filed and recorded in the office of the Register of Wills of Baltimore City in Liber R.
