church near Westmiaster; and that the said Trusters, by the name aforesaid, and their successors, to be elected as hereinafter mentioned, shall have perpetual succession, and be able and capable in law to purchase, take, have, hold, receive and enjoy, to them and their successors, in fee simple or for any lesser estate, any laids, to empats, reuts, hereditaments, or other real estate whatsoever, by grant, gift, bargain, sale, devise or otherwise; Provided, that the lands which shall be acquired by and vested on the said corporation, by virtue of this a it, shall not exceed in the whole, the quantity of three hundred acres; and the same lands, tenem uts, rents, hereditaments, and real estate, (excepting always the said church called Chrise's church, and the lot of ground, grave vard, and appertenances there to belonging, or therewith now used and occupied,) to give, grant, bargain, sell and convey, demise, or otherwise dispose of, in whole or in part, as to them shall seem meet, for the use of the said religious society; and also that the said trustees, by the name aforesaid, shall be able and capable in law to sue and be sued, implead and he impleaded. answer and be answered unto, defend and be defended, in any suits or actions, and in all or any courts whatsoever, and that it shall and may be lawful to and for the said Trustees, by the name aforesaid, to devise, make, have and use one common seal, to authenticate all and every the acts, deeds and instruments touching their basiness, and the same seal at their pleasure to break, after and tenew, and generally the said Trust es, by the name afore aid, shall have, hold and enjoy, all and singular the rights, privileges, liberties and franchises, ineldent and belonging to a religious exponation or body politic, as fully and effectually, as any other religious corporation

or body politic in this state, has right to have, hold and capay. See 2.
