Thereupon it is Comanded the Sheriff of Somerset County that he should take the said Abigail and bring her to answer to the Court of his Lordship held at Bishops Cleeve on the third Tuesday of August being the eighteenth day of the same Month Anno Domini thousand seven hundred and sixty One before the Justice thereof the said Abigail Tomlinson in her proper Person and had a hearing of the judgment of the Court which she cannot deny but that she is Guilty of the Premises in the judgment of above upon her proposed in manner and form as by the judgment of above Against her supposed but will not declare the father but is willing to pay a double fine for the same to Whosever all and singular the Premises being seen and by the Court fully understood and considered by the Court here that the said Abigail Tomlinson for the Premises and Offense of above specified doth owe and pay to the Sheriff of Somerset County the sum of three pound ten shillings which she pay to the Sheriff of the County of Somerset for the use of the County to Whosever the said Abigail Tomlinson is bound to be guilty to save and keep indemnified the Justice of Somerset County from all Costs Charges and troubles that may Arise by means of the birth of the Bastard Child of the said Abigail Tomlinson and doth acknowledge himself indebted with his Lordship in the sum of thirty pound ten shillings of Money of their Lords Goods and Chattels Lands and Tenements to be made and Levied if it happen that Abigail Tomlinson do not save and keep indemnified the Justice of Somerset County Court from all Costs Charges and troubles that may Arise by means of the birth of a Bastard Child of the body of the said Abigail
