 of June next then they shall be condemned according to the Act of Assembly
 to and for y^e use of a certain John White unless the said Stevens White by himself
 or his attorney shall appear answer unto y^e said John White in a plea of Debt
 & according to Law, that by good and Lawfull men of your County who you
 make known unto y^e person or persons in whose hands you make y^e same
 Attachment that he she or they be, appear before our Justices of our County
 Court of Somerset to be held as aforesaid to shew Cause if any he she or they have why
 y^e same Goods & Chattels & Credits so attached in his her or their Hands ought
 not to be condemned & Execution thereof had & made according to Act of Assembly
 in such Case made & provided if to him her or them if shall seem meet & how you
 shall Execute this Writ that you make known unto our said Justices at the
 day & place aforesaid and have you there this Writ with witness Isaac Handy Esq^r one
 of our Justices of our said Court the 21st day of March in the 9th year of our Dominion
 & Anno Domini 1760
