Whereupon all and singular the Premises being seen and by the Court fully understood it is Comanded by the Court here that the said Aron Tillman for the Premises and Offences aforesaid in the Judgment of P. P. specified be taken which said Aron Tillman present hereon Court aforesaid for the premises and Offences of the sum of five Shillings & Money which he paid down to the Sheriff for the use of his Lordship the

The same We the Grand Jury for the County of Somerset County upon Our Oath do present - Certain Sarah Dawson formerly named Sarah Ballard of Somerset Parish that she had unlawfully did bear a bastard Child against the form of the Act of Parliament in such Case made and provided and so forth

Thereupon it is Comanded the Sheriff of Somerset County that he should Take the said Sarah Dawson if she should be found in his Bailynk and that she should safe keep so that he might have her body before the Justice of his Lordships County Court of Somerset to be had at Binses Lane Town the thirdd Tuesday of March Anno Domini 1762 to answer unto his said Lordships of and concerning the Judgment of P. P.

At which day here came the said Sarah Dawson in her proper person and had a hearing of the Judgment of P. P. that she can deny but that she is guilty of the Premises in the Judgment of P. P. above upon her imposed in manner and form as by the Decree of P. P. above against her supposed but will not declare the father of the bastard Child of P. P. but is willing to pay her fine for the same according to Act of Parliament in such Case provided &c. Whereupon all and singular the premises being seen and by the Court fully understood it is Comanded by the Court here that the said Sarah Dawson for the premises and Offences aforesaid be taken which said Sarah Dawson is fined for the same of the sum of three pounds & Money which she paid to the Sheriff for the use of the County &c.

Whereupon the said Sarah Dawson is ordered to give security to save keep and defend the Justice of Somerset County from all such Charges and Troubles that may accrue by means of the birth of the bastard Child of P. P. Thereupon certain Justice of the Peace of Somerset County present hereon Court in his proper person undertook for the said Sarah Dawson and acknowledged himself to be held and firmly bound unto the said Lordship the said Lordship by tenibly bound and Money of Mayland of this said County and Charles Lawes and to payments to be made and levied if it happen that the said Sarah Dawson should and keep and defend the Justice of Somerset County Court from all such Charges and Troubles that may accrue by means of the birth of the bastard Child of P. P.
