Whereupon it is Comanded the Sheriff of Somerset County that he doth take the said Sarah Game if he can answer the said Sarah Game the 10th day of March Anno Domini 1762 at Princes Anne Town before the Justices thereof the said Sarah Game in her proper person and thereupon the said Sarah Game had hearing of the Justices of the said County Court that she is Guilty of the premises in the Defamation of Above upon her disposed in manner and form as by the Defamation of Above Against her supposed Whereupon all and singular the premises being seen and by the Court fully considered it is Comanded by the Court here that forasmuch as there is due to the County of Somerset Seven years service from such persons as are Guilty of Indenture Copulation and likewise that the Year begun by such Copulation become a servant until he arrive at the Age of Thirty One years. Whereupon it is Comanded that the said Sarah Game become a servant for Seven years for such Copulation as aforesaid and that the said Sarah Game the Year of the said Sarah Game and by the Copulation of become a servant until he arrive at the Age of thirty One years
