Six pound eight Shillings & Money
& Daniel in Maner &c

Command was given to the Sheriff of Somerset County that he should let John
William Figg into Somerset County the night if he should be found in his bail and he
should safe keep that he might have his Day before the Justice of his Lordships County Court of Somerset to be
held at Quince Ann Town the third Tuesday of August next to come thereon to show himself a Debtor
to answer unto Richard Daugherty of the same County with fine and costs the Case of the said Richard Daugherty
to be done
