William Thomas Howard a Command was given to y<sup>e</sup> Sheriff of Somerset County that he  
should take John Caldwell of Somerset County Prisoner  
if he should be found in his County with him should safe keep  
so that he might have his Body before y<sup>e</sup> Justices of his Indisputable County Court  
Somerset to be held at Cranes Am Towne the Tuesday June Anno Domini one  
thousand seven hundred & fifty eight to answer unto Thomas Howard of plea of trespass  
upon y<sup>e</sup> Case &c

and y<sup>e</sup> same day is given to y<sup>e</sup> of Thomas here and Joseph

At which day he came y<sup>e</sup> of Thomas Howard by William Hayward his  
attys y<sup>e</sup> Sheriff to wit William Hayward now here returned that he had taken  
y<sup>e</sup> of John Caldwell whose Body he at this day he had body to answer y<sup>e</sup>
