And afterwards in the same Court came as well George Hayward sent his Lordships Attorney who for his said Lordship in this part prosecuteth as the ap John Records in his proper person, the sheriff to wit Ephraim Wilson now here returned the ap writ of Venire Facias and the names of the Jurors in all things served and Executed, the Names of that Jury thereof Impanelled being called to wit William Morrin, John Piper, Robert Clacy, William Turpin, Elias White, Aaron Sterling, Thomas Handy, John Anderson, Joshua Hitch, Jonathan Full, Nehemiah Borman, William Roberts came who to say the Truth of the premises ap being Elected Sworn upon their oath say that the ap John Records is not guilty of the premises in the Judgment mentioned above upon him Imposed in manner and form as the ap John Records above by pleading hath alleged Therefore it is considered that the ap John Records of and from the Judgment ap be discharged &c thereof without Day &c

And Whereupon the same Attorney of the same Lord property for the said Lord property prays advice of the court here in the premises, that due process of Law in this part may be made against the said Mary to answer of and upon the premises &c

Thereupon it is commanded the sheriff of Somerset County that Immediately he should take the ap Mary Jones if she should be found in his Bailiwick, or should safe keep so that he might have her body before the Justices of his Lordships County Court of Somerset now sitting at princeps Ann Town this Instant March to answer unto his said Lordship of concerning the Information ap &c

And afterwards in the same Court came the ap Mary Jones in her proper person, had a hearing of the Information ap faith that she cannot deny but that she is guilty of the premises in the Information on ap above upon her Imposed in manner &c form as by the Information ap above against her Imposed and maketh Oath that John Full is the Father of the child she stands informed against and is willing
