and Right to all the Kings Subjects Rich and Poor according to the Laws Customs and
Directions of the Act of Assembly of this Province so far forth as they provide and where
they are silent according to the Laws Statutes and Reasonable Customs of England and
Practised within this Province for the Conservation of the peace and Quiet Rule and
Government of the Kings Subjects within our said County and to Chastise and Punish
all or any Person or Persons offending against the said Act Laws Statutes and Customs
or any of them according to the directions thereof and to call before you or any of you
all those who in our County aforesaid shall threaten to do any bodily harm to any of the Kings
Subjects or to burn their houses or otherwise break our peace and Misbehave themselves
to find sufficient Security of the peace and good behaviour to us and the said Subjects -
and if they shall Refuse to find such security that then you cause them to be committed
into safe Custody until they shall be delivered by due Course of Law from thence Also we
have Asigned you and every three or more of you of whom we will you the said Benjamin
Tasker, Charles Hammond, Samuel Chamberlain, Edward Lloyd, Richard Lee, Benedict
Calvert, Robert Jenkins Henry, Daniel Dulany, Stephen Bordley, John Ridout, Charles
Goldsbrough, William Hayward, Samson Wheatly, Joseph Gillis, Samuel Adams, William
Winder and Ephraim Wilfor or One of you always to be one our Justices to inquire by the Oath
of God and Painfull Men of our County aforesaid by whom the truth of the Complaints may be
